

1. On 24<sup>th</sup> September 2003 the Prosecution filed a Response to the Defence Motion for Extension of time for Leave to Appeal against the Decision and Consequential Order of Judge Benjamin Mutanga Itoe dated 22<sup>nd</sup> July 2003 refusing an Application for Bail or Provisional Release.
2. The Prosecutor notes that in Paragraph 15, line 5/6 of the Response, the Prosecution refers to the provisions of Rule 45 (C) of the Rules of Procedure which it erroneously submits requires the Principal Defender assigned to be available on a full time basis to the case.


3. Paragraph 15, line 5/6 shall instead read "the provisions of Rule 45 (C) of the Rules of Procedure which requires the assigned counsel appointed by the Principal Defender, be available on a full time basis to the case".


