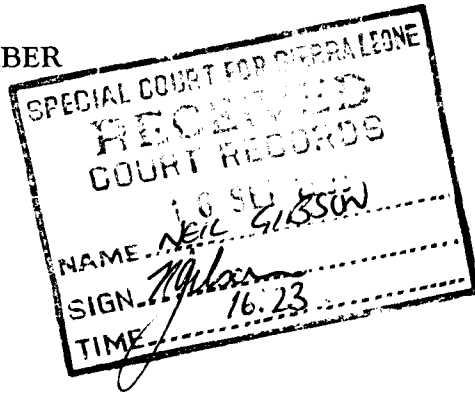

**WARRANT OF ARREST AND ORDER FOR TRANSFER AND DETENTION**

THE SPECIAL COURT FOR SIERRA LEONE (“the Special Court”),

SITTING AS Judge Pierre Boutet, designated pursuant to Rule 28 of the Rules of Procedure and Evidence (“the Rules”);

CONSIDERING that an Indictment has been reviewed and approved on the 16<sup>th</sup> day of September 2003 against **Santigie Borbor Kanu, also known as 55, also known as Five-Five, also known as Santigie Khanu, also known as Santigie Kanu, also known as S.B. Khanu, also known as S.B. Kanu, also known as Santigie Bobson Kanu, also known as Borbor Santigie Kanu (“the Accused”)**, a citizen of Sierra Leone born in March 1965 in Maforki Chiefdom, Port Loko District, Republic of Sierra Leone, or in Freetown, Republic of Sierra Leone, **charging** him with Crimes Against Humanity, Violations of Article 3 Common to the Geneva Convention and Additional Protocol II, and Other Serious Violations of International Humanitarian Law;

CONSIDERING also that on the 16<sup>th</sup> day of September an Order for the Non-Disclosure of the Indictment, or part thereof, and of all or any part of any information pertaining to the Indictment, the Warrant of Arrest and Order for Transfer and Detention until further order of the Special Court was issued;

HEREBY ISSUES this Warrant of Arrest and Order for Transfer and Detention of “**the Accused**”

AND, CONSEQUENTLY

ORDERS TO THE REGISTRAR OF THE SPECIAL COURT:

- (A) To address, pursuant to Rule 55 of the Rule, this Warrant of Arrest and Order for Transfer and Detention, the Decision Approving the Indictment, the Approved Indictment against **Santigie Borbor Kanu, also known as 55, also known as Five-Five, also known as Santigie Khanu, also known as Santigie Kanu, also known as S.B. Khanu, also known as S.B. Kanu, also known as Santigie Bobson Kanu, also known as Borbor Santigie Kanu (“the Accused”)** and a Statement of the Rights of the Accused to the National Authorities of Sierra Leone;
- (B) To cause to be served on “**the Accused**”, at the time of his arrest, or as soon as possible thereafter, in English or have read to him in a language he understands, a certified copy of the Warrant of Arrest and Order for Transfer and Detention, a certified copy of the Indictment, a certified copy of the Decision Approving the Indictment and a statement of the rights of the Accused and to caution him that any statement made by him shall be recorded and may be used as evidence against him in coordination with the National Authorities;
- (C) To remand “**the Accused**” into the custody of the Special Court Detention Facility or such other detention facility as determined by the President in accordance with Rule 57.


**RESPECTFULLY ORDERS TO THE RELEVANT AUTHORITIES OF THE  
REPUBLIC OF SIERRA LEONE:**

- (A) To search for and arrest “**the Accused**”;
- (B) To arrange with the Registrar of the Special Court for the transfer “**the Accused**” to the custody of the Special Court and to transfer “**the Accused**” without delay.
- (C) To assist and facilitate the Office of the Prosecutor, at any location, in the search for and seizure of all evidence related to the crimes alleged to have been committed by “**the Accused**”;
- (D) To identify and locate assets owned by “**the Accused**” located within the territory of Sierra Leone and adopt provisional measures to freeze such assets without prejudice to the rights of third parties;
- (E) To not disclose to the public, including the media or any public record, the existence of the Indictment and this Warrant of Arrest, or any part thereof or information pertaining to the Indictment and this Warrant of Arrest until further order of the Special Court;

In case of inability of **The Government of Sierra Leone** to immediately execute the present Warrant of Arrest and Order for Transfer,

**The Government of Sierra Leone** is requested to indicate the reasons thereof.
