ARREST AND ORDER FOR TRANSFER AND DETENTION**

THE SPECIAL COURT FOR SIERRA LEONE ("the Special Court"),

SITTING AS Judge Pierre Boutet, designated pursuant to Rule 28 of the Rules of Procedure and Evidence ("the Rules");

CONSIDERING that the Indictment against **Santigie Borbor Kanu**, also known as 55, also known as Five-Five, also known as Santigie Khanu, also known as Santigie Kanu, also known as S.B. Khanu, also known as S.B. Kanu, also known as Santigie Bobson Kanu, also known as **Borbor Santigie Kanu** ("the Accused") was reviewed and approved by myself on the 16th day of September 2003;

CONSIDERING the Decision Approving the Indictment, the Warrant of Arrest and Order for Transfer and Detention and Order for Non-Public Disclosure of the 16th day of September 2003 ("the Decision");

CONSIDERING the Warrant of Arrest and Order for Transfer and Detention of "the Accused" issued on the 16th day of September 2003;

CONSIDERING that "the Decision" provided, *inter alia*, for the non-disclosure of the Indictment or part thereof and of all or any part of any information pertaining to the Indictment, the Warrant of Arrest and Order for Transfer and Detention until further order of the "Special Court";

HAVING RECEIVED on the 18th day of September 2003 a request from the Prosecution for the public disclosure of the Indictment against "the Accused", and of the Warrant of Arrest and Order for Transfer and Detention;

HAVING BEEN INFORMED by the Prosecution that "the Accused" has been arrested and transferred to the detention unit of "the Special Court" and that the non-disclosure of the Indictment, Warrant of Arrest and Order for Transfer and Detention is no longer justified;

CONSIDERING that it would be in the public interest to now proceed with such disclosure;

NOW THEREFORE,


PURSUANT to Rules 52 and 54 of "the Rules",



HEREBY ORDERS the public disclosure of the Indictment against “the Accused”, of the Warrant of Arrest and Order for Transfer and Detention, and of the Decision Approving the Indictment, the Warrant of Arrest and Order for Transfer and Detention and Order for Non-Public Disclosure;

The additional material supporting the Indictment shall not be disclosed to the public until further order of “the Special Court”.
