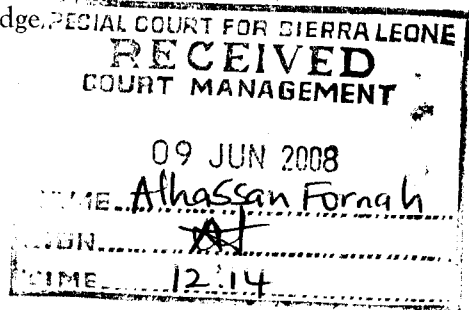


NOTING that the names of certain Prosecution Counsel were omitted from the cover page of the written Appeal Judgment filed on 28 May 2008;

RECTIFIES the cover page of the Appeal Judgment to include the names of Prosecution Counsel Chile Eboe-Osuji and Anne Althaus as follows:

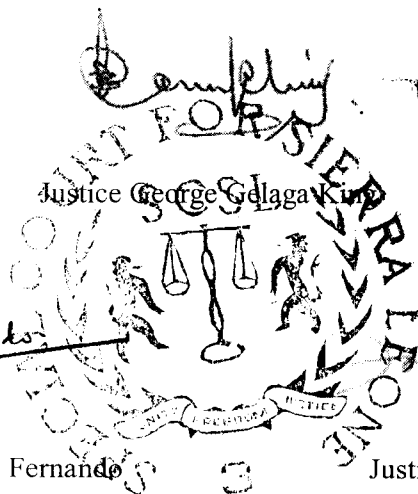


