I, RENATE WINTER, the Pre-Hearing Judge in this case;

SEISED of the "Urgent Joint Defence and Prosecution Motion for an Extension of Time for the

Filing of Response Briefs" filed on 21 September 2007 (the "Motion");

NOTING that the Defence for all three Convicted Persons and the Prosecution are seeking an

extension of the time limit for filing their response briefs under Rule 112 of the Rules of

Procedure and Evidence;

NOTING that Rule 112 provides that the Respondents shall serve their submissions on the other

Parties and file them with the Registrar within fourteen days of filing the Appellants' submissions;

CONSIDERING that the Parties, in light of the length of their appeal briefs, jointly request an

extension of 11 days so that they may file their response briefs on 8 October 2007 instead of on 27

September 2007;

**CONSIDERING** that the Parties have already been granted an extension of time within which to

file their appeal briefs and considering the need of the Appeals Chamber to dispose of this appeal

in an expeditious manner by avoiding undue delay;

I HEREBY GRANT the Motion in part by allowing the Parties an extension of 7 days so that they

shall submit their response briefs no later than 4 October 2007.
