
SUMMON Brima Bazy KAMARA to appear before the Special Court via video conference from the International Criminal Tribunal for Rwanda sub-office in Kigali, Rwanda, on Friday, 15 July 2011 at 11:00 a.m. (GMT +2) to answer charges of contempt pursuant to Rule 77 of the Rules;

DIRECT the Registrar, in cooperation with the Rwandan Prison Authorities, to ensure that **Santigie Borbor KANU** and **Brima Bazy KAMARA** are available to appear before the Special Court via video conference from the International Criminal Tribunal for Rwanda sub-office in Kigali, Rwanda, on Friday, 15 July 2011 at 11:00 a.m. (GMT +2) to answer charges of contempt pursuant to Rule 77 of the Rules;

ORDER Santigie Borbor KANU and **Brima Bazy KAMARA** to comply with the schedule for the initial appearance communicated to them by the Registrar of the Special Court.
