

INTERIM DECISION ON PROSECUTOR'S ADDITIONAL STATEMENT OF ANTICIPATED TRIAL ISSUES AND REQUEST FOR SUBPOENA

I, Justice Teresa Doherty, Single Judge of the Special Court for Sierra Leone ("Special Court");

SEISED of the "Prosecutor's Additional Statement of Anticipated Trial Issues and Request for Subpoena," filed on 11 June 2012 ("Application"), wherein the Independent Counsel requested the Trial Chamber pursuant to Rule 54 to issue a subpoena to Andrew Daniel and Claire Carlton-Hanciles requiring their appearance before the Trial Chamber to give testimony;

NOTING the "Defence Pre-Trial Brief on Behalf of Santigie Borbor Kanu filed pursuant to the Scheduling Order of 1 May 2012," filed on 29 May 2012, wherein counsel for Santigie Borbor Kanu opposed the issuance of a subpoena to either Daniels or Carlton-Hanciles;

NOTING the "Defence Pre-Trial Brief on Behalf of Brima Bazzy Kamara," filed on 1 June 2012, wherein counsel for Brima Bazzy Kamara opposed the issuance of a subpoena to either Daniels or Carlton-Hanciles;

NOTING AND RECALLING the oral arguments made by Independent Counsel and both Counsel for the Accused Kanu and Kamara made on 16 June 2012;

## HEREBY ISSUES THE FOLLOWING INTERIM DECISION AND ORDER:

### I. DELIBERATIONS

- 1. I do not consider that the lawyer-client privilege vested in a client by Rule 97 of the Rules of Procedure and Evidence ("Rules") is absolute if the purpose of the communication is obtaining advice on the commission of a future crime. Accordingly, the application for a subpoena requiring Andrew Daniels to appear and give evidence is granted and shall issue forthwith.
- 2. I will give a fully reasoned decision on this ruling and on the further issue, as to whether the privilege existed between Daniels and the Accused when the alleged communications were made, when time permits.
- 3. In relation to the application to subpoena Claire Carlton-Hanciles, the Principal Defender, I request and appoint Professor William Schabas, pursuant to Rule 74 of the Rules, to prepare and submit an Amicus Brief on the application of Rule 97 and the Code of Professional Conduct for

Counsel with the Right of Audience before the Special Court for Sierra Leone to the Principal Defender.

4. I further request the Registrar to serve the annexed Subpoena on the said Andrew Daniels by email.

# FOR THE ABOVE REASONS, THE TRIAL CHAMBER

DIRECTS that Andrew Daniels shall appear to give evidence as soon as practicable.
