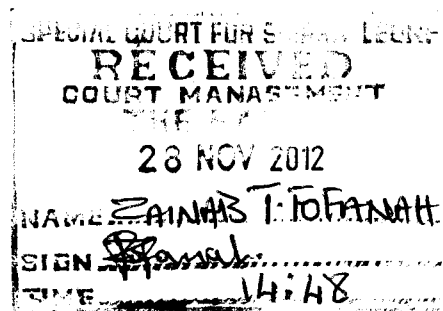

I, Justice Teresa Doherty, acting as Single Judge of Trial Chamber II of the Special Court for Sierra Leone (“Special Court”);

**NOTING** that the Independent Counsel has applied for a *subpoena duces tecum* for the production of the bank account of Prince Taylor of Bo, Sierra Leone held at the First International Bank (SL), LTD.

**NOTING** that the Single Judge of Trial Chamber II has ordered that the First International Bank, (SL), Ltd. produce the bank account or accounts of Prince Taylor of Bo for the period 1 January 2011 – 31 July 2011 to the Registrar of the Special Court for Sierra Leone as soon as practical.

**PURSUANT** to Rule 54 of the Rules of Procedure and Evidence of the Special Court (“Rules”);

**HEREBY ORDERS YOU** to produce:

- a) the aforesaid bank account/accounts of Prince Taylor of Bo for the period 1 January 2011 to 31 July 2011 inclusive to the Registrar of the Special Court for Sierra Leone; and
- b) any record or documentation related to the cash deposit of 200,000 Leones made to the account of Jessica Senessie on 1 February 2011.

**NOTING** that wilful failure to comply with the terms of this subpoena constitutes contempt of the Special Court pursuant to Rule 77 of the Rules. Should you fail to comply, the Trial Chamber may deal with the matter summarily itself, refer the matter to the appropriate authorities of Sierra Leone or, if there are sufficient grounds to proceed against you for contempt, issue an order in lieu of an indictment and direct independent counsel to prosecute the matter. If you are convicted for contempt of the Special Court you may be imprisoned for up to seven (7) years or fined up to twenty (20) million Leones, or both;

**HEREBY INFORMS YOU** that:

REQUESTS the Registrar of the Special Court to take all necessary measures to have this subpoena served and executed, seeking the assistance of authorised representatives of the Government of the Republic of Liberia where appropriate.
