**FURTHER RENEWED WITNESS LIST PURSUANT TO ORDER TO THE
PROSECUTION CONCERNING RENEWED WITNESS LIST**

1. On 23 November 2004 the Prosecution filed a Renewed Witness List consisting of 102 “core witnesses” and 170 “back-up” witnesses.
2. On 3 December 2004 the Trial Chamber issued its Order to the Prosecution Concerning Renewed Witness List. Pursuant to that Order, the Prosecution files a further renewed witness list. Annex 1 comprises 98 “core” witnesses. Of these 25 have already given evidence. Annex 2 comprises 163 “back-up” witnesses.
3. The Prosecution responds to the specific Orders of the Trial Chamber as follows.
 - i. The Prosecution does not seek leave of the Trial Chamber to add witnesses TF1-189 and TF1-274 to its “core” witness list. The Prosecution confirms that these witnesses have been deleted from its witness list and they no longer appear in Annex 1.


- ii. The Prosecution does not seek leave of the Trial Chamber to add witness TF1-126 to its “core” witness list. This witness is listed on the “back-up” list at Annex 2.
 - iii. The Prosecution does seek leave of the Trial Chamber to add witness TF1-210 to the “core” list. This witness is listed in the “core” list at Annex 1. The Prosecution is aware of the presumption in doing so, but submits that this inclusion is done for ease of reference. Witness TF1-210 was previously inadvertently deleted from the core list. This witness has an identical name to another TF1 witness and the removal from the “core” list arose from confusion between the two witnesses.
 - iv. The Prosecution does not seek leave of the Trial Chamber to add witnesses TF1-106, TF1-146, TF1-103 and TF1-276 to its “back-up” witness list. The Prosecution confirms that these witnesses have been deleted from its witness list and they no longer appear in Annex 2.
 - v. The Prosecution does not seek leave of the Trial Chamber to add witnesses TF1-013, TF1-155 and TF1-302 to its “back-up” witness list. The Prosecution confirms that these witnesses have been withdrawn from the witness list and they no longer appear in Annex 2.
4. Further, the Prosecution informs the Trial Chamber that:
- i. Witnesses TF1-348 and TF1-359 have been deleted from the Prosecution witness list and no longer appear in either Annex 1 or Annex 2.
 - ii. Witness TF1-085 has been moved from the “core” to the “back-up” list and now appears in Annex 2.
5. In addition, the Prosecution respectfully informs the Trial Chamber of its decision to move witnesses TF1-029 and TF1-122 from the “back-up” to the

“core” list. The Prosecution submits that it does not require leave of the Trial Chamber to move witnesses from the “back-up” to the “core” list, as doing so involves no addition to the list of witnesses filed with the Trial Chamber on 26 April 2004. The list of 266 witnesses was filed on that date pursuant to the Order to the Prosecution to File Disclosure Materials and Other Materials in Preparation for the Commencement of Trial dated 1 April 2004. The Order of the Trial Chamber was for the Prosecution to file a list of witnesses it intended to call at trial with the caveat that if the Prosecution intended to add any witness after 26 April 2004 it could do so only upon good cause being shown. The Prosecution submits therefore that for witnesses who have not been identified as deleted or withdrawn from the original list of 266, it does not require leave of the Trial Chamber to move them between the “back-up” and “core” lists.


6. However, if the Trial Chamber is of the view that leave is so required, the Prosecution seeks that leave. The selection of the “core” witnesses is sometimes displaced by the inability, unsuitability or latent unwillingness of such witnesses to give evidence. In such circumstances, the Prosecution may seek to substitute “core” witnesses with “back-up” witnesses. The Prosecution intends to call witness TF1-029 instead of witness TF1-085, referred to in paragraph 4.ii. above. The Prosecution intends to call witness TF1-122 instead of witness TF1-126, referred to in paragraph 3.ii. above. The Prosecution notes that again for ease of reference these two witnesses already appear in the “core” list at annex 1.
