

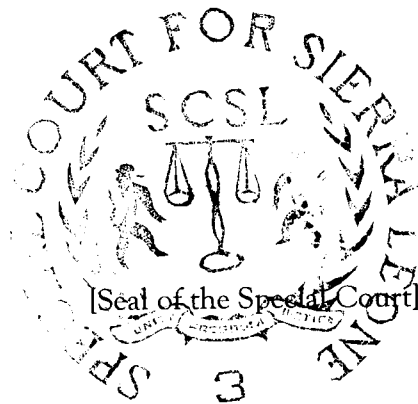
1. The Hon. Justice Bankole Thompson filed today his "Comments on Sesay, Kallon and Gbao Joint Motion for Voluntary Withdrawal or Disqualification from the RUF Case Filed Pursuant to Rule 15 of the Rules of Procedure and Evidence".¹
2. The Document was filed in response to the Sesay and Gbao Joint Motion ('Defence Motion').²

4. That the word 'technique' should be removed from the second last line in paragraph 11.
5. The first sentence in paragraph 21 should read as follows:

It is extremely disingenuous to contend that in paragraph 37 of my Opinion, I found that the AFRC/RUF authorities did share a "common plan, purpose or design (joint criminal enterprise)....."
