
1. The Defence filed its Witness Order for the week commencing 28 June 2010 on 14 June 2010 (“Witness Order”) which includes Witness DCT-172 as one of the Witnesses scheduled to testify in that week.¹ Subsequently, the Defence filed its Notification of Potential Exhibit to be used in Connection to Witness DCT-172 on 16 June 2010.²
2. Due to an unforeseen situation relating to the ailment of Defence Lead Counsel, the Defence requested for an adjournment. The Trial Chamber II granted the adjournment and modified the starting date of Witness DCT-172’s testimony to 5 July 2010.³
3. On 5 July 2010, the Defence filed its Version XX of Defence Rule 73ter Filing of Exhibit List listing a number of documents as potential exhibits, Defence Exhibits DCT-430 to DCT-438. These documents listed in the Defence Rule 73ter of Exhibit List are additional potential exhibits to be used in connection to DCT-172.
4. The Defence, therefore, files this notification of additional potential exhibits providing the parties a list of additional anticipated exhibits to be used in connection to DCT-172 which can be found in Annex A to this filing.
5.
