TRIAL CHAMBER II ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court");

SEISED of the "Urgent and Public with Annexes A and B Defence Request for a Status Conference Pursuant to Rule 65bis" filed on 18 January 2011 ("Request"),1 wherein the Defence requests the Trial Chamber to convene a status conference pursuant to Rule 65bis of the Rules of Procedure and Evidence ("Rules") as soon as practicable;

CONSIDERING that it is in the interests of justice to give the Defence an opportunity to explain why it failed to file its final trial brief on 14 January 2011, as ordered,<sup>2</sup> and why it has refused to accept service of the Prosecution final trial brief;3

- 2. response by the Defence to any ensuing concerns.<sup>4</sup>
