

PUBLIC URGENT PROSECUTION REQUEST FOR INTERIM MEASURES

I. Introduction

1. Pursuant to Rule 73(A) of the Rules of Procedure and Evidence ("Rules"), the Prosecution files its urgent request for interim measures.

II. BACKGROUND

- 2. On 8 March 2007, the Prosecution filed "Urgent Prosecution Motion for Immediate Protective Measures for Witnesses and for Non-Public Disclosure ("Motion")¹.
- 3. On 19 March 2007, the Prosecution filed "Urgent Prosecution Motion for Leave to Substitute a Supplemented Witness List as Annex A (4) of the Confidential Urgent Prosecution Motion for Immediate Protective Measures for Witnesses and for Non-Public Disclosure filed on 8 March 2007" ("Supplemental Motion")², seeking leave for the witness list attached to the Motion to be supplemented, and if so granted, to substitute Annex A (4) of the Motion with Annex A (5) attached to the Supplemental Motion.
- 4. On the same day, the Defence filed "Response to Urgent Prosecution Motion for Immediate Protective Measures for Witnesses and for Non-Public Disclosure."³
- 5. On 21 March 2007, the Prosecution filed "Prosecution's Reply to 'Defence Response to 'Urgent Prosecution Motion for Immediate Protective Measures for Witnesses and Non-Public Disclosure."

III. URGENT REQUEST FOR INTERIM MEASURES

6. If protective measures order(s) sought in the Motions are issued prior to the forthcoming judicial recess, the Prosecution shall disclose to the Defence, prior to

4 April 2007, redacted statements of all witnesses listed in the combined Annex filed with the Motion.

7. Absent such order(s), the Prosecution requests that the Trial Chamber issue an order no later than 29 March 2007 permitting the transmission of the above referenced disclosure material to the Court Management Section of the Registry no later than 30 March 2007, for disclosure to the Defence once a decision on protective measures has been rendered. This request and the interim measures sought are consistent with past practice⁵ and ensure that the Prosecution has fulfilled its disclosure obligations pursuant to Rule 66 (A) (ii) of the Rules.

IV. CONCLUSION

8. The Prosecution respectfully requests the Trial Chamber to grant the orders for protective measures sought in the pending Motions.⁶ If the Trial Chamber is unable to issue such order(s) prior to the forthcoming judicial recess, the Prosecution requests that the Trial Chamber issue an order no later than 29 March 2007 allowing transmission of disclosure material to the Court Management section as requested in paragraph 7 above.
