TRIAL CHAMBER II ("Trial Chamber") of the Special Court for Sierra Leone ("Special Court");

SEISED of the "Prosecution Motion for Leave to Re-Classify as "Public" a Motion Previously Filed on an *Ex Parte* & Confidential Basis" filed on 14 November 2007 ("Motion")¹, wherein the Prosecution requests the Trial Chamber to order Court Management Services to re-classify the *Ex Parte* and Confidential Prosecution "Motion for an Order to Provide to the Prosecution Non-Privileged Recently Obtained Documents From the Accused's Personal Archive" ("previous motion")², as "public" on the grounds that "it is now appropriate to lift the confidential and *ex parte* status of the motion in order to ensure that the Defence and public have access to all the information concerning the issue and the motion";

NOTING that the Defence did not file a response to the Motion;


RECALLING the Trial Chambers' Decision on *Ex parte* and Confidential Prosecution Motion for an Order To Provide to the Prosecution Non-Privileged Documents Recently Obtained from the Accused's Personal Archive, issued on 5 November 2007;³


HOLDING that it would be in the interests of justice for the previous motion to be re-classified as "public";

GRANTS the Motion and orders Court Management Services to re-classify the "*Ex parte* and Confidential Prosecution Motion for an Order to Provide to the Prosecution Non-Privileged Documents Recently Obtained from the Accused's Personal Archive", as "public".
