URGENT PROSECUTION REQUEST FOR DECISION

I. INTRODUCTION

- On 28 January 2008, the Defence filed an application to exclude the evidence of Prosecution expert witness Corinne Dufka or, in the alternative to limit its scope.¹
- 2. The Prosecution filed its response to the application on 1 February 2008² and the Defence filed its Reply on 7 February 2008.³ A decision on the Application is pending. In addition to *viva voce* testimony, the Prosecution sought to introduce numerous exhibits through this witness.⁴

II. REQUEST

- 3. The Prosecution respectfully requests that the Trial Chamber urgently decide this outstanding Application. The Prosecution requires a decision in order to effectively and efficiently organise and present its case. The Trial Chamber's decision may require the Prosecution to elicit additional evidence and/or to introduce documentary evidence by other means. This in turn would involve re-evaluation of existing evidence and would possibly require additional investigation and recourse to additional witnesses in order to provide the type of evidence offered by this witness. This process would also have logistical consequences, which the Prosecution would be required to deal with in a timely fashion.
- 4. For all these reasons it would be helpful to the Prosecution's ability to plan its case to have the decision on this Application urgently decided, and the Prosecution respectfully requests that the Trial Chamber do so.
