- 1. The Defence files this Response to the Prosecution's Motion to Allow Witness TF1-303 to give Testimony by Video-Link, which was filed on 28 October 2008 ("the Application").
- 2. The Defence does not oppose the Prosecution's request for this particular witness to testify by video-link.²
- 3. Regarding the Prosecution's application for the rescission of protective measures applying to the witness, the Defence does not object to the witness testifying openly. The Defence, however, reiterates its position concerning the applicability of the RUF decision of 5 July 2004 ("RUF Decision")³ to witnesses other than those specified in categories A, B and C of the said decision; a matter that is *sub judice*.⁴
