

## Public Prosecution Application to Correct the Transcript of 19 May 2010

- 1. The Prosecution hereby requests the Trial Chamber, pursuant to Rule 81 (B) of the Rules of Procedure and Evidence ("Rules"), to order the amendment of the final public transcript of 19 May 2010 of the proceedings in the present case.
- 2. While reviewing the transcript of 19 May 2010 in preparation for the cross examination of a Defence witness, the Prosecution noticed a possible translation or transcribing error in an answer of a witness who testified that day, on page 41167, lines 12 17, where the witness is recorded as saying "C boy" rather than "Saye Boayue":

..."A. C boy was the commander. He was in charge.

MR ANYAH: Madam President, I believe that name is on the record previously, Saye Boayue. I can have the witness spell it, but I am fairly certain it's on the record:

Q. Mr Dehmie, can you spell Saye Boayue?

A. Yes, sir."...

- 3. On 1 June 2010, the Prosecution contacted the Court Management Section with a request for the Court Reporters to listen to the audio tape of the proceedings of that day and check the possible error. The Court Reporters reviewed the audio tape of the 19 May proceedings and determined that the term "C boy" was indeed a transcribing error which should read "Saye Boayue".
- 4. Therefore, to ensure the preservation of the full and accurate record of the present proceedings, the Prosecution requests the Trial Chamber to order that the transcript of 19 May 2010 be corrected by replacing the words "C boy" on page 41167, line 12, with "Saye Boayue".
