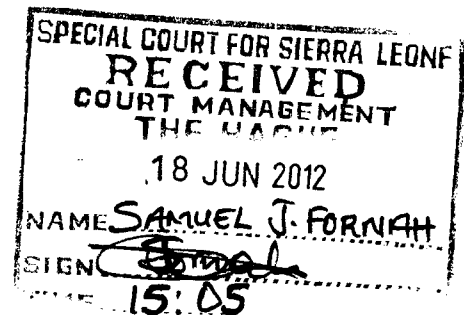



Judgement in this case was delivered by Trial Chamber II on 26 April 2012,¹ which was accompanied by a judgement in writing, issued on 18 May 2012.² A corrigendum to the Judgement was issued on 30 May 2012³ and served on the parties on 31 May 2012.⁴ The Sentencing Judgement was likewise served on the parties on 31 May 2012.⁵
2. The Defence provides notice of its intention to file a notice of appeal, pursuant to Rule 108 of the Rules of Procedure and Evidence.⁶ On the basis of this notice, the Defence hereby consents to the appointment of the Pre-Hearing Judge contemplated under Rule 109 of the Rules.


