09:29:51	5	JUSTICE DOHERTY: Good morning. I'll take appearances,
	6	please. Mr Gardner, I think you're appearing for independent
	7	counsel. Mr Gardner, are you with me? Can you hear me?
	8	MR GARDNER: No, I can't. I think what happens,
	9	Your Honour, is the microphones all go to something called FLO
09:30:33	10	and they have to be switched.
	11	JUSTICE DOHERTY: So I've discovered. I don't know who the
	12	mystery switcher is, but I noticed that yesterday. So I just
	13	switched mine back. I'm just taking appearances.
	14	MR GARDNER: I have a faulty headset, excuse me,
09:30:53	15	Your Honour.
	16	JUSTICE DOHERTY: I have a spare one up here. Whilst
	17	you're getting yourself sorted out there, Mr Gardner, I'll take
	18	appearances from Mr Lansana.
	19	MR LANSANA: As it pleases, Your Honour.
09:31:16	20	JUSTICE DOHERTY: Good morning.
	21	MR LANSANA: Good morning. Ansu Lansana, counsel for
	22	Mr Senessie.
	23	JUSTICE DOHERTY: And I note the accused appears from bail.
	24	MR LANSANA: Yes, Your Honour.
09:31:31	25	JUSTICE DOHERTY: William Gardner, Your Honour, Independent
	26	Counsel for the Prosecutor.
	27	JUSTICE DOHERTY: Thank you, Mr Gardner. When we adjourned
	28	yesterday, we had an indication from Defence counsel that the
	29	accused would elect to give evidence. If that is still the case,

- 1 then as I indicated yesterday under the Rules he is obliged to
- 2 give evidence first. And if he is still of that opinion, then he
- 3 should be called first. Mr Lansana, can you inform the Court of
- 4 the situation, please.
- 09:32:08 5 MR LANSANA: Yes, Your Honour, the situation is the same.
  - 6 The accused has opted to testify, and I would call him first.
  - 7 JUSTICE DOHERTY: Thank you. Please proceed. Mr Lansana,
  - 8 you should go over to the witness box, please.
  - 9 MR LANSANA: Mr Lansana?
- 09:32:30 10 JUSTICE DOHERTY: Mr Senessie. You may have noticed I've
  - 11 already explained it's a family failing.
  - 12 MR LANSANA: I know. I understand that.
  - 13 JUSTICE DOHERTY: Mr Lansana, what language will the
  - 14 witness give his evidence in ?
- 09:33:29 15 MR LANSANA: Your Honour, I'm sorry but I should have
  - 16 informed the Court earlier. The witness will testify in Krio.
  - 17 JUSTICE DOHERTY: Thank you. Are the Krio interpreters in
  - 18 position?
  - 19 THE INTERPRETER: Yes, Your Honour.
- 09:33:44 20 JUSTICE DOHERTY: Please proceed to swear the witness or
  - 21 affirm, whichever he elects.
  - 22 [ERIC KOI SENESSIE, ON OATH]
  - 23 [EXAMINATION-IN-CHIEF BY MR LANSANA]
  - 24 MR LANSANA:
- 09:34:36 25 Q. Would you state your name for the Court, please?
  - 26 A. My name is Eric Koi Senessie.
  - 27 JUSTICE DOHERTY: Mr Senessie, you may sit or stand,
  - whi chever you prefer.
  - 29 A. I'm going to speak in Krio.

- 1 MR LANSANA:
- 2 Q. Good morning, Mr Senessie?
- 3 A. Good morning, sir.
- 4 JUSTICE DOHERTY: Mr Lansana, maybe it would be pertinent
- 09:35:25 5 before you proceed to remind Mr Senessie that his evidence is in
  - 6 public, that some of the witnesses are protected witnesses, and
  - 7 he knows which ones are protected witnesses and he should avoid
  - 8 saying their names out loud. And if he's got any doubt, then he
  - 9 should stop and ask either you or me for guidance.
- 09:35:51 10 MR LANSANA: As a matter of fact, Your Honour, I have
  - 11 covered that. That is why he has those yellow post its.
  - 12 JUSTICE DOHERTY: I see. In that case you have adequately
  - 13 covered it. I don't need to say --
  - 14 MR LANSANA: With the pseudonyms of the witnesses are
- 09:36:06 15 protected.
  - 16 JUSTICE DOHERTY: Very good. Thank you.
  - 17 MR LANSANA: As Your Honour pleases.
  - 18 Q. Mr Senessie, you say your name is Eric Koi Senessie,
  - 19 correct?
- 09:36:20 **20** A. Yes, sir.
  - 21 Q. Where do you live?
  - 22 A. I'm living in Kailahun. That's where I was born.
  - 23 Q. Can you tell this Court what your occupation is?
  - 24 A. After the war, I used to report for SLBC and I was also
- 09:36:43 25 engaged in carving and farming.
  - 26 Q. Are you a family man?
  - 27 JUSTICE DOHERTY: For purposes of record, SLBC means?
  - 28 MR LANSANA: Your Honour, the Sierra Leone Broadcasting
  - 29 Corporation.

- 1 Q. Yes, I just asked you whether you are a family man?
- 2 A. Yes, sir, I am a family man.
- 3 Q. How many wives and how many children?
- 4 A. I have two wives.
- 09:37:33 5 Q. And how many children?
  - 6 A. I have eight children.
  - 7 Q. Mr Senessie, you are aware that there was a war a rebel
  - 8 war in this country, not so, between 1991 and 2002 or
  - 9 thereabouts?
- 09:38:08 10 A. Yes, sir.
  - 11 Q. And there was a warring faction called the Revolutionary
  - 12 United Front; are you aware of that?
  - 13 A. Yes, sir.
  - 14 Q. Did you have anything to do with the Revolutionary United
- 09:38:41 15 Front?
  - 16 A. Yes, sir.
  - 17 Q. During what time and in what capacity?
  - 18 A. When the war entered on 23 March 1991, I was in Mobai when
  - 19 the RUF abducted me and rescued me on 29 March, I was involved in
- 09:39:15 20 the war. The first person whom they came with was the
  - 21 cartographer who used to read the map died at the boundary.
  - 22 Thereafter they looked amongst us for those who were literate and
  - 23 selected me as a cartographer and I was heading the cartographic
  - 24 office in the military intelligence branch in the RUF. And after
- 09:39:38 25 that they opened a training base in Bo Number One. I became the
  - ideology lecturer, a tutor at the base.
  - 27 Q. Thank you. And you're aware that sometime during the war
  - there were attempts at negotiating peace, correct?
  - 29 A. Yes, sir.

- 1 Q. Did you play any role in the peace negotiations?
- 2 A. Yes, sir.
- 3 Q. Can you please tell this Court what that role was?
- 4 A. After the Lome Peace Accord and in agreement with the Lome
- 09:40:27 5 Peace Accord when we were told to transform into a political
  - 6 party and during the time of the disarmament, during the
  - 7 transition to peace I acted as a member of the peace mediating
  - 8 team. Apart from that, when the RUF transformed itself into a
  - 9 political party I was the first district party chairman for
- 09:40:58 10 Kailahun District and I ensured that I consolidated and
  - 11 coordinated and consolidate the peace process, and in 2002 I
  - 12 ensured that we took part in the political sector and took part
  - 13 in the peaceful elections of this country. I also ensured that
  - 14 we disarmed without any problem in this country and even today
- 09:41:24 15 our area is very peaceful as I speak to you?
  - 16 Q. Thank you. You mentioned a few statements ago something
  - 17 about transition of the RUF into the RUFP, the Revolutionary
  - 18 United Front party. Can you please tell this Court what your
  - 19 distinctive roles were. You've indeed said that you were
- 09:41:56 20 chairman, district chairman. What was your specific role as
  - 21 district chairman of the RUFP?
  - 22 A. When I became the district chairman for the RUFP in the
  - 23 political sector I was responsible for the political wing in the
  - 24 district. I ensured that every RUF those who had said they
- 09:42:31 25 wanted to become a member of the RUF, I brought them together and
  - 26 we ensured that we took part in the political sector, and we
  - 27 conducted the elections peacefully. I brought the people on
  - 28 board for them to register for that party. Some people those
  - 29 who were willing to become members, registered and up until now,

- 1 they are members of the RUF. So that was my role that I played
- 2 in the political sector.
- 3 Q. Thank you very much. You're aware that after the war the
- 4 Special Court for Sierra Leone was established, specifically to
- 09:43:19 5 try those who bore the greatest responsibility for infringement
  - 6 of human rights and crimes against humanity, not so?
  - 7 A. Yes, sir. I knew about that.
  - 8 Q. At the time the Special Court was established, where were
  - 9 you?
- 09:43:57 10 A. I was in Kailahun. During this time, as my lawyer is
  - 11 asking, I with in Kailahun when the Special Court was established
  - 12 in this country. During that time I was in Kailahun and I used
  - 13 to see investigators going there, including some lawyers. At one
  - 14 time there was one lawyer that I could remember who went as a
- 09:44:14 15 Prosecutor. His name was Chris Bomford. He was the first
  - 16 lawyer. He met me at my house and asked me to testify. I said I
  - 17 would consider it, but now that you've come, we are afraid. We
  - 18 are thinking that they would arrest everybody, so on that day I
  - 19 was unable to speak to Chris Bomford. Chris Bomford asked me if
- 09:44:40 20 I could help him.
  - 21 JUSTICE DOHERTY: Mr Witness I think you're going a bit
  - 22 fast. The interpreter has to keep up with you and someone has to
  - write what you are saying so a little more slowly, please.
  - MR LANSANA: As Your Honour pleases.
- 09:44:53 25 JUSTICE DOHERTY: Please continue. You mentioned Chris
  - 26 Bomford met you at your house. People were afraid. They thought
  - 27 me might be charged, please continue from there.
  - 28 THE WITNESS: At that time. At that time that Chris
  - 29 Bomford went, all of us were afraid. Chris Bomford asked me

- 1 would you be able to help me to get some few people that I can
- 2 talk to? I selected Sam Kolleh who was the CSO, chief security
- 3 officer, CSO, chief security officer. I told him about him and
- 4 we--
- 09:45:40 5 JUSTICE DOHERTY: Pause, Mr Witness.
  - 6 MR GARDNER: Could we get some further identification on
  - 7 Chris bomb Ford, Prosecution, Defence.
  - 8 JUSTICE DOHERTY: I heard him say he was a lawyer and
  - 9 before that Prosecutors and investigators came but we can specify
- 09:45:57 10 his exact status.
  - 11 MR LANSANA: As it please Your Honour.
  - 12 Q. You mentioned Chris Bomford. Can you please say for
  - 13 certain whether he was a member of the Prosecution team or a
  - member of the Defence team, please?
- 09:46:14 15 A. At the time that Chris Bomford went, well, I think he was -
  - 16 I could still remember that he was I don't know whether he was
  - 17 for the Prosecution, because at that time we were in a hurry. At
  - 18 that time I just introduced him to Sam Kolleh and we went to him.
  - 19 It was at that time that Sam became angry and even insulted me
- 09:46:39 20 alleging that I have revealed his identity to the man. That was
  - 21 a long time ago, because when they used to go at that time, we
  - 22 didn't take a lot of things into consideration. I think the
  - 23 records would tell whether Chris Bomford was a Prosecution
  - 24 witness or Defence.
- 09:47:03 25 Q. Yes, you were saying something about the --
  - 26 A. Yes. Apart from that, all the lawyers used to go I can
  - 27 recall one Logan Hambrick and Prince Taylor also they used to go.
  - 28 They were in the Defence. They told me that they asked me to
  - 29 testify, but I thought that apart from that, Serrita, who was a

- 1 Defence lawyer Issa Sesay, they too went and they asked me to
- 2 testify. John Cammegh they too went. As they went in and out I
- 3 thought that my position I was in a dilemma because each time
- 4 they went they would be in Freetown here where they would give
- 09:48:10 5 them my name, that when they go that they should meet the
  - 6 district chairman of the RUFP Eric Koi Senessie who'll be able to
  - 7 help you. So each time they went they would go to me. So I
  - 8 thought that I was to be neutral because both the Defence and the
  - 9 Prosecution used to meet me. So I used to help the Prosecution
- 09:48:28 10 to give them good the names of people. Most of them who had
  - 11 been there to testify. I used to give them their names and they
  - 12 will meet them. Defence will come to me and I will give them
  - 13 names and they will meet the people. So I was very instrumental
  - 14 then. So on those grounds I regarded myself as one who be
- 09:48:51 15 neutral. So I was just between them. I did not take part I
  - 16 did not testify. But at one time I want to remind this Court
  - 17 that Serrita called me to come --
  - 18 MR LANSANA:
  - 19 Q. Serrita who was Serrita?
- 09:49:14 20 A. Serrita was a Defence Lawyer for Issa Sesay.
  - 21 Q. And Issa Sesay was who?
  - 22 A. Issa Sesay was the former leader of the RUF. By then he
  - 23 had been indicted and he was in Court here.
  - 24 Q. Please continue with the lady you were talking about?
- 09:49:44 25 A. Yes, Serrita called me up and asked me to testify for Issa
  - 26 Sesay but when I came a lot of people whose names I had given to
  - 27 them had come. So Serrita said okay, Eric Senessie, you can
  - 28 return.
  - 29 JUSTICE DOHERTY: Mr Senessie, please pause.

- 1 MR GARDNER: I object to this, Your Honour. What he did
- 2 and didn't do for Prosecution and Defence in the Charles Taylor
- 3 case may be at issue, but some other case that's not related to
- 4 those earlier cases, I don't see what the relevance of it is.
- 09:50:21 5 JUSTICE DOHERTY: Yes, Mr Lansana, there's a relevance
  - 6 issue here.
  - 7 MR LANSANA: Yes, Your Honour, the relevance issue is this:
  - 8 In the statement of TF1-585, there is indication that the
  - 9 witness was at Zulu in 2007. She met the witness at the Zulu
- 09:50:47 10 where they were prepping Defence Prosecution witnesses in 2007.
  - 11 And it's in issue because this witness was a potential witness
  - 12 for the Defence and in 2007, Zulu was not used for prepping
  - 13 Defence witnesses. That is an issue. I think it needs to be
  - 14 clarified. I would need it for my final address.
- 09:51:13 15 JUSTICE DOHERTY: If that is the issue and it's to do with
  - 16 I don't recall TF1-585 mentioning Zulu under oath in Court. It
  - 17 may be in the statement, which --
  - 18 MR LANSANA: Yes, Your Honour.
  - 19 JUSTICE DOHERTY: But I think it would be pertinent to go
- 09:51:32 20 straight to that point.
  - 21 MR LANSANA: As Your Honour pleases.
  - 22 Q. Mr Senessie, you said you were approached to testify on
  - 23 behalf of Issa Sesay, correct?
  - 24 A. Issa Sesay and Gbao.
- 09:51:53 25 Q. And Gbao. And those were --
  - 26 A. Yes, Gbao's Lawyer was John Cammegh. He approached me to
  - 27 testify for Gbao. Those of us who came were many, so I did not
  - 28 testify in Court, so I returned and left those whom we had come
  - 29 together. So I was not in Zulu to testify or to become a Defence

- 1 witness for Charles Taylor at all.
- 2 MR LANSANA: Your Honour, I think that is covered.
- 3 JUSTICE DOHERTY: I'm not sure where Charles Taylor came
- 4 into John Cammegh and Gbao, because he said Issa Sesay was
- 09:52:40 5 charged as the leader of the RUF and Mr Taylor was indicted
  - 6 alone, so where is the connection for him saying he didn't
  - 7 testify for Taylor?
  - 8 MR LANSANA: Maybe you need to clarify that.
  - 9 Q. Mr Senessie?
- 09:53:02 10 A. Yes, I said this because I saw it. I read it in TF1-585's
  - 11 statement that she met me in Zulu where I was being prepped to
  - 12 become a Defence witness for Charles Taylor, and it did not
  - 13 happen that way. I went there on behalf of Gbao and Issa Sesay.
  - 14 Q. Thank you. Will you please continue?
- 09:53:31 15 A. So as I was there, I returned to Kailahun. So we were in
  - 16 Kailahun up to date. We've been in Kailahun up to date.
  - 17 Q. Thank you.
  - 18 JUSTICE DOHERTY: I haven't ascertained for the record when
  - 19 he was in Zulu being prepped for Gbao and Sesay. What date is
- 09:53:57 **20** this?
  - 21 MR LANSANA:
  - 22 Q. Now, Mr Senessie, when the Defence called you to testify
  - 23 for Issa Sesay, when was that? Can you tell the Court what year
  - 24 that was?
- 09:54:17 25 A. It's been a long time now. We did not keep such records,
  - 26 but I can recall it was around 2000 either 5 or 6. From 5, 6 to
  - 27 7. I cannot remember without certainty because I was not
  - 28 recording it. We just used to come and return. Maybe the record
  - 29 will tell.

- 1 Q. Thank you.
- 2 JUSTICE DOHERTY: Where exactly is Zulu?
- THE WITNESS: Zulu, from this Court you go up a little.
- 4 Zulu is close to this place. It's not far off. During Issa
- 09:55:02 5 Sesay's time when I came I was staying at Zulu. There is another
  - 6 guesthouse behind the street. When I came, that was where I was.
  - 7 It's a storied building. That is where I was for Gbao. I was
  - 8 not at Zulu. I was not at Zulu at Gbao's time.
  - 9 MR LANSANA:
- 09:55:24 10 Q. Thank you?
  - 11 A. Yes, sir.
  - 12 Q. Now, you've said that you were to' ing and fro' ing between
  - 13 Kailahun and Freetown and eventually you returned to Kailahun to
  - 14 settle down?
- 09:55:42 15 A. Yes, sir.
  - 16 Q. During that time specifically in relation to the RUFP what
  - 17 can you say your interaction was with the following people:
  - 18 TF1-274, for a start?
  - 19 A. In the first place, TF1-274, TF1-585, TF1-516 and Mohammed
- 09:56:29 20 Kabbah Bereteh all of them by then when I returned at the time
  - 21 that they disarmament had not taken place when all of us were in
  - 22 Kailahun they were at a radio station and TF1-274 was their boss
  - 23 and all of them were together. I did not have much interaction
  - 24 with these people because they did something to me that could
- 09:56:55  $\,$  25  $\,$  have caused my death. So even during the time of the peace
  - 26 processor even the RUF, the RUFP period I did not have much talk
  - 27 with them. These people were at a radio station after the attack
  - 28 on Zambians and Kenyans in Makeni. We were in Kailahun. Those
  - 29 who bear the greatest responsibility of the war who are now in

	1	Panga Prison, we were in Kailahun and we received information
	2	from the Military Police office and it was sent to TF1-274 saying
	3	that we too should attack the Indians in Kailahun. But being
	4	that I was the RUFP district chairman now, the soldiers and the
09:57:54	5	civilians were loyal to me. So I took my time and called a very
	6	big meeting and said no, this information that we've received
	7	from Makeni, I won't allow anybody to work on it. Now the war
	8	has jumped over us to Makeni, I won't allow anybody to take up a
	9	gun in this country any more. We need peace. TF1-274, TF1-585,
09:58:30	10	TF1-516, Mohamed Bereteh Kabbah they were annoyed, because they
	11	were the Black Guards. They were supporting Foday Sankoh. They
	12	were with Foday Sankoh. They sent immediate information about me
	13	to the headquarters in Makeni saying Eric Koi Senessie and two
	14	strong personnel in the RUF that is Woneh and Mahile that we have
09:59:01	15	incited people for them not to fight any more. So from there
	16	they sent an immediate message to TF1-274 ordering her - ordering
	17	him to arrest me. These people reported to Sam Kolleh. They
	18	were very instrumental. They brought soldiers together who
	19	arrested me together with my two brothers and they took us to
09:59:29	20	Makeni and from there they sent us to the front line not knowing
	21	that they had an intention to execute us at the front lines. So
	22	when we were there, that night that they asked us to go on
	23	attack, God just told me that we were going and I hid in the
	24	bush. When my brothers got to Masiaka, they opened firing. At
09:59:53	25	that time there was fighting between the Sierra Leone government
	26	forces and the ECOMOG. Our brothers went and attacked. During
	27	that attack, they willfully fired my two brothers because that
	28	was the intention that we were to be killed at the front lines.
	29	But I hid.

- 1 THE INTERPRETER: Your Honours, can he repeat this last bit
- 2 and slow down.
- 3 JUSTICE DOHERTY: Mr Senessie, you've definitely speeded up
- 4 again. I'm having trouble keeping up with you and so is the
- 10:00:20 5 interpreter. So.
  - 6 THE WITNESS: I apologise.
  - JUSTICE DOHERTY: The other thing, Mr Senessie, it seems to
  - 8 me from what you're telling me that we have gone back into the
  - 9 wartime. The question, as I understood it, was directed at and
- 10:00:42 10 I'll quote the question, "You came used to go and come and then
  - 11 you returned it Kailahun and you settled and what was your is
  - 12 your relation ship with 274." You said he nearly caused your
  - 13 death and now you're talking about the Indian peacekeepers who
  - 14 have long since departed, although I'm not putting that in as
- 10:01:05 15 evidence, and the attack at Masiaka and that is into the wartime.
  - 16 My understanding is the question was your current more recent
  - 17 relationship. I do not entirely see what the relevance of this
  - wartime relationship is.
  - 19 MR LANSANA: Your Honour, if I may.
- 10:01:27 20 MR GARDNER: Your Honour, actually my notes reflect that he
  - 21 was asked about his interaction with 274 and he gratuitously
  - 22 added three more to it.
  - JUSTICE DOHERTY: Yes, he did.
  - 24 MR LANSANA:
- 10:01:43 25 Q. Mr Senessie, I specifically did not want to group all of
  - them together. I wanted you to tell this Court your working
  - 27 relationship with 274 vis-a-vis the RUFP?
  - 28 A. 274 in the RUFP most likely was not with us in Kailahun.
  - 29 After we had disarmed TF1-274 went back to his hometown in Bo.

- 1 He was not with us in Kailahun. Recently I think one year ago he
- 2 came to Kailahun. I just saw him working with [redacted].
- 3 Q. Thank you. And TF1-585?
- 4 A. TF1-585, this woman is my first cousin's daughter. We in
- 10:02:45 5 Kailahun almost in the same compound. Almost 50 metres from my
  - 6 compound to their house. She's was given birth to by my first
  - 7 cousin. I even played a part in her education. I was helping
  - 8 her mother to pay her school fees so we were living together.
  - 9 The relationship was somehow cordial after the war when we were
- 10:03:10 10 in Kailahun. She left Kailahun.
  - 11 Q. Was TF1 has TF1-585 ever been a member of the RUFP?
  - 12 A. They are members of the RUFP. They are members of the
  - 13 RUFP.
  - 14 Q. And up until when was she an active member?
- 10:03:49 15 A. You mean both of them?
  - 16 Q. Take them one after the other. Let's concentrate on
  - 17 TF1-585 vis-a-vis RUFP?
  - 18 A. TF1-585, RUFP, it was it is at this time that she came
  - 19 that she started mingling with us.
- 10:04:18 20 THE INTERPRETER: Your Honour, can this witness be advised
  - 21 to take his answer slowly.
  - JUSTICE DOHERTY: Mr Senessie you've speeded up again and
  - as I've explained the interpreter has to interpret everything.
  - 24 So sense by sentence. You've said at this time." Continue from
- 10:04:39 25 there. Sentence, pause.
  - 26 THE WITNESS: At this time TF1-585 we were not even
  - 27 disarmed when Mosquito broke away from the RUFP and went to
  - 28 Liberia. As he was going to Liberia, TF1-585 joined Mosquito's
  - 29 group and they left for Liberia. She had been there for a

- 1 considerable time. She left Liberia in 2000 I think around 6
- 2 and 7 when she returned here. She was not with us in the RUF.
- 3 It was when we revived the RUF that I have seen her mingling with
- 4 the RUF party for now, the RUFP.
- 10:05:48 5 MR LANSANA:
  - 6 Q. There is an allegation before this Court by TF1-585 that on
  - 7 Thursday, 27 January 2011, in the evening hours, you visited her
  - 8 house, is that correct?
  - 9 A. It's not correct at all. This woman is my daughter. I
- 10:06:21 10 usually pay her visits. I'll go to her house, she will come to

  - 17 Q. Can you give specific instances of such visitations?
  - 18 A. Yes. Sometimes and occasionally when they have weddings
  - 19 like when her sister was getting wedded, I went there. My child

  - 21 Q. Just hold it. Let's have specific dates. First and
  - 22 foremost, go back to your mentioning of TF1-585's sister's
  - 23 wedding. What month was it? What year was it? And what
  - 24 happened?

  - 26 place, but it was in March when this TF1-585's youngest sister
  - 27 was getting wedded. My family and their family all met in one

  - 6 asking you whether the wedding took place after January 2011?
  - 7 A. The wedding was in 2011.
  - 8 Q. And was it after January?
  - 9 A. When the wedding took place, yes, it was in March. After

  - 11 Q. Thank you very much. Now, let's go to your loss of a son.
  - 12 Can you give the specific date of the loss and what happened?
  - 13 A. My child died on 14 February 2010 and when my child died,
  - 14 TF1-585 left Freetown. She was in Freetown when she cried on the
- 10:09:40 15 phone. She spoke to her mother and asked her to bring the phone
  - 16 to me. She brought the phone to me, saying my daughter wants to

  - 11 Q. Excuse me. When you say she said she had been asked to be
  - 12 a witness for Charles Taylor, do you mean she told you that she

  - 13 fear so I did not even come. I saw someone who was my brother
  - 14 Sam Fajabi. He was coming to Bo. I gave him that document. I

- 1 JUSTICE DOHERTY: You remember. Very well.
- 2 MR LANSANA: Thank you, your Honour.
- 3 Q. Mr Senessie, although you say you didn't go to the

  - 12 five witnesses to ask you for contact information because they
  - 13 would be worried that you would report it to the OTP, with whom
  - 14 you had worked?

  - 16 intentions. I did not know their intentions. They only
  - 17 requested for complimentary card.
  - 18 Q. But sir, they didn't know your intentions, did they?

  - 16 contacted the investigators and turned you in; you understand
  - 17 that?
  - 18 A. I know. That was their plan. That was what they did.
  - 19 They know why they did it. That was what they did. That's the
- 13:25:38 20 case that is here.
  - 21 Q. Which one of these five do you blame the most for turning
  - 22 you in?
  - 23 A. The master planner who brought all of this up. Like I told
  - you in the office at the time that you were investigating me, I
- 13:26:01 25 said this contempt allegation started from the 1st, 2nd and 3rd.
  - 26 The person whom I'm blaming is 274. He caused all of this
  - 27 problem.
  - 28 Q. 274 caused all of this problem?
  - 29 A. 274.

- 1 Q. Okay. Now let's go through what the record in this case
- 2 shows about the chronology of contacts. Start with 274. He
- 3 testified that you came to him on February 2, okay, and you
- 4 didn't have a complete conversation. You next contacted him the
- 13:26:54 5 next day on February 3. Do you remember his testimony?
  - 6 A. I remember all of it.
  - 7 Q. And do you remember that the very next day he called
  - 8 investigator Joseph Saffa. Remember that?
  - 9 A. I remember according to their testimony.
- 13:27:15 10 Q. [Microphone not activated] you remember?
  - 11 A. Yes.
  - 12 Q. So it didn't take but one day one day for 274 to turn
  - 13 you in after you came to him and talked to him about meeting with
  - 14 Prince Taylor and recanting his testimony. Now let's go to
- 13:27:37 15 Mohamed Kabbah. He testified that his initial contact with you
  - 16 was January 26. He was the first person you contacted. He
  - 17 testified that the next day, one day later, he contacted Magnus
  - 18 Lamin, the investigator. Do you recall that testimony?
  - 19 A. Yes.
- 13:28:02 20 Q. It only took him one day to call and report your improper
  - 21 conduct. Aruna Gbonda, he testified he came to your house on
  - 22 January 29; remember that?
  - 23 A. I know.
  - 24 Q. And he too called the investigators right away. And 516,
- 13:28:37 25 he was a little slow. You first no, I take that back. Strike
  - 26 that. He met with Mr Kabbah on January 28. And then on January
  - 27 30 he met with the investigators. That was his testimony. And
  - 28 then you came and contacted him on February 1. So by the time
  - 29 you came and made your approach to him about going to see Prince

- 1 Taylor to change his testimony, he had already gone to the
- 2 prosecutors. Do you understand that testimony?
- 3 A. I heard everything. That was what they said.
- 4 Q. And 585, she talked about your surprise visit on January
- 13:29:28 5 27, and the record is clear that she went to the investigators on
  - 6 January 28?
  - 7 A. Which record?
  - 8 Q. The record here, the transcript of the Court.
  - 9 A. That was what she said.
- 13:29:48 10 Q. Yeah. Okay?
  - 11 A. But do you know that when somebody has plotted --
  - 12 Q. There's no question pending, sir. Just wait for the next
  - 13 questi on.
  - 14 JUSTICE DOHERTY: Mr Gardner, I appreciate you're getting
- 13:30:11 15 into your flow there, but it is actually after the usual lunch
  - 16 break and if staff and so on are to get anything, we'll have to
  - 17 break now.
  - 18 MR GARDNER: I'm comfortable with whatever your Honour
  - 19 wants.
- 13:30:29 20 JUSTICE DOHERTY: I will adjourn the Court for an hour, and

  - 9 excerpt from your testimony this morning regarding 585. You
- 14:36:15 10 said, referring to 585, that she met with you on February 8 and
  - 11 asked for Prince Taylor's number. You remember that testimony?
  - 12 A. February 8th. You mean 585?
  - 13 Q. No, I meant I meant February 8, 2011, you testified that
  - on that day 585 asked you for Prince Taylor's phone number.
- 14:36:57 15 A. 585 met me on the 9th. She went to my place on the 8th.
  - 16 THE INTERPRETER: Your Honour, the witness is speaking
  - 17 English now.
  - 18 JUSTICE DOHERTY: Mr Senessie, you've slipped into English.
  - 19 You should let us know which language you're using so that the -
- 14:37:19 20 THE WITNESS: Yes, my lord. The Krio is not talking now.
  - 21 JUSTICE DOHERTY: Oh, I see. Let me clear that up. Is the
  - 22 Krio interpreter in place?
  - 23 THE INTERPRETER: Yes she is.
  - JUSTICE DOHERTY: Oh. Then it must be something to do with
- 14:37:36 25 the machine. I'll ask the court attendant to please check the
  - wi tness's machine.
  - 27 THE WITNESS: I can get you clearly now.
  - 28 MR GARDNER:
  - 29 Q. Let me repeat the question. You testified on direct that

- on February 8, 585 asked you for Prince Taylor's phone number.
- 2 Do you remember that?
- 3 A. I remember that but it was not on the 8th of February. It
- 4 was on the 9th.
- 14:38:31 5 Q. Okay. We'll call it the 9th. Now, it is in evidence in
  - 6 this case that 12 days before February 9 12 days before
  - 7 February 9 on January 28, 585 called the investigators to say
  - 8 that you proposed that she meet with Prince Taylor so she can
  - 9 recant her testimony The Hague. You know that's what she
- 14:39:09 10 testified to, don't you, Mr Senessie?
  - 11 A. I did not tell her -
  - 12 Q. No, no I am asking you whether you heard that testimony
  - 13 in this courtroom. Yes or no?
  - 14 A. Please repeat.
- 14:39:35 15 Q. Do you recall 585 testifying that you approached her and
  - 16 made a surprise visit with her on the 27th and that on the 28th
  - 17 she called the investigators to report your improper contact
  - 18 about recanting her testimony. Do you recall what she said in
  - 19 Court?
- 14:40:04 20 A. I remember that.
  - 21 Q. And now did you also have the chance to see the Prosecution
  - 22 exhibit in court of 585's statement to the Prosecutors, to the
  - 23 investigators? Do you recall that statement? Did you read it?
  - 24 A. I read it when he gave his testimony about me.
- 14:40:38 25 Q. You mean when she gave her testimony about you?
  - 26 A. Well, the testimony the statement that they passed onto
  - 27 my lawyer that he passed onto me, I read it. That's what I mean.
  - 28 Q. Okay. Now did you notice, Mr Senessie, that that statement
  - 29 was dated February 28, 29 no, I'm sorry, January 28th, January

- 1 29th, and February 1; meaning that 585 met with the investigators
- 2 on all three of those days. Did you understand that?
- 3 A. I understand that.
- 4 Q. Now the significance of that, Mr Senessie, is that
- 14:41:38 5 according to the evidence 585 was already on record as reporting
  - 6 you for your improper contact about recanting testimony long
  - 7 before you claim that on February 9 she wanted Prince Taylor's
  - 8 phone number. You understand that?
  - 9 A. I understand that, but someone who has plotted against you
- 14:42:14 10 can do anything. At the time that she met me, that's the time I
  - 11 have told you. That is what she said, that that is the time she
  - 12 met me. And there is no other person between myself and her who
  - 13 would clarify that it was at this time that TF1-585 met me. She
  - 14 told you her own date and I told you my own date that I said she
- 14:42:44 15 met me, because I knew that it was a plot against me.
  - 16 Q. A big conspiracy? A big conspiracy against you?
  - 17 A. I am quite sure.
  - 18 Q. But understand, conspiracy or not, that all five of these
  - 19 witnesses were on record with the investigators as complaining
- 14:43:15 20 about your illegal improper conduct, while at the same time you
  - 21 say you are giving them Prince Taylor's contact number. Don't
  - you understand, they can't possibly be having any interest in
  - 23 getting Prince Taylor's number because they've already told the
  - investigators that you've approached them about recanting your
- 14:43:46 25 testimony? Do you understand that?
  - 26 A. I understand that, but I did not do that. I did not meet
  - 27 anybody. They was the ones who used to meet me. Did I not meet

- 1 his testimony.
- 2 Q. Nobody told you he was going to recant his testimony? Is
- 3 that your testimony? Are you saying that?
- 4 A. That someone told me he was going to recant his testimony
- 14:44:31 5 in The Hague, is that what you mean?
  - 6 Q. You just -
  - 7 MR LANSANA: Your Honour, I'm sorry to interrupt. I would
  - 8 only want counsel to caution himself, because there are certain
  - 9 facts that he is putting to the witness that are not correct. He
- 14:44:54 10 may be misleading the witness. For instance, he's saying that
  - 11 all five Prosecution witnesses were on record as having contacted
  - 12 the Prosecution before -
  - 13 JUSTICE DOHERTY: No, he didn't say that. He said they

- - 16 MR LANSANA: That's what I'm saying. That they had made

- 14:45:53 25 MR GARDNER: Well, Your Honour, as to 274, the date that I
  - 26 referred to new my cross-examination as relevant was February 4
  - 27 when 274 contacted investigator Joseph Saffa. That's my point.
  - 28 274 is on record as having contacted the investigators before the
  - 29 conversations that Mr Senessie says took place.

- 1 JUSTICE DOHERTY: I have not got I don't want to take up
- 2 a lot of time going through my notes to see when Senessie says
- 3 274 contacted him. But the fact is that the point you are
- 4 putting is that prior to the time the witness says these people
- 14:46:44 5 came and contacted him, the complaints were, if not all five,
  - 6 four of them certainly were on record, if that is the question
  - 7 you are putting?
  - 8 MR GARDNER: Precisely, Your Honour.
  - 9 JUSTICE DOHERTY: Well, I'll allow that question.
- 14:46:59 10 MR GARDNER:
  - 11 Q. Do you understand that, Mr Senessie?
  - 12 A. I am hearing you.
  - 13 JUSTICE DOHERTY: And counsel then followed up with another
  - 14 question which I would like to see the answer to, and that was
- 14:47:17 15 picking up something Mr Senessie said in his answer. No one told
  - 16 you that anyone was going to recant. I may not have worded it
  - 17 properly, but that question has not been answered.
  - 18 MR GARDNER: Well, that's the next point I was going to
  - 19 tackle, Your Honour.
- 14:47:33 20 Q. Did you just say a moment ago, the Judge heard it, and I
  - 21 heard it, that no one said to you that they was going to go to
  - 22 The Hague to recant their testimony? Did you say that? Yes or
  - 23 no, Mr Senessie?
  - 24 A. Well, I said remember --
- 14:48:01 25 Q. Yes or no, Mr Senessie.
  - 26 A. You've asked me a question. I'm working it out. Because
  - 27 something that had happened, I need to work it out. It's
  - 28 something that had happened.
  - 29 Q. Mr Senessie --

- 1 A. You should listen.
- 2 Q. Mr Senessie, if you need to work it out and think about it,
- do it in silence, because that question calls for a "yes" or "no"
- 4 answer, and if you like I will repeat?
- 14:48:34 5 A. Go over it.
  - 6 Q. Isn't it true that you testified just a few moments ago, as
  - 7 the Court heard, and as I heard, that no one told you that they
  - 8 was going to go to The Hague to recant their testimony. Yes or
  - 9 no?
- 14:49:00 10 A. Well, I say "just yes" or no. I want to say something.
  - 11 Q. You answer the question yes or no, and then the Court will
  - 12 give you an opportunity to explain your answer. You must answer
  - 13 it -
  - 14 A. No.
- 14:49:16 15 Q. That's the correct answer, because that's oh, you're
  - 16 saying no, you did not say that. Okay. Well, Mr Senessie, the
  - 17 record will reflect that you did say that, and it was not a true
  - 18 statement, because on your direct examination, you said
  - 19 specifically, with respect to 274, that he said that he would go
- 14:49:36 20 and recant and that he said that on February 1st. That was your
  - 21 direct testimony.
  - 22 A. Well, that is what I said, that I would just say "yes" or

  - that TF1-274 made when JP Combey, who is Joseph Combey intervened

  - 26 He just told me -

- 1 A. Well, I said that, but during the discussion it was TF1-274
- 2 who said it. That is why when you asked me, even if I had said
- 3 yes, I worked it out again and I reflected my mind to TF1-274's
- 4 statement that he made, loudly, openly in public.
- 14:50:47 5 Q. [Overlapping speakers]
  - 6 A. He did not tell me. He just said it openly.
  - 7 Q. You finished your answer. TF1-274 said that. You finished
  - 8 your answer?
  - 9 A. He said it.
- 14:51:00 10 Q. Now, you claim that 274 is the ring leader, is that right?
  - 11 A. Yes.
  - 12 Q. He's the leader of the five witnesses?
  - 13 A. Well, that is what I believe because he pioneered this.
  - 14 Ever since we've been there, nobody ever came around to ask me
- 14:51:25 15 about Prince Taylor's complimentary card or Logan's complimentary
  - 16 card. That is what brought all of this.
  - 17 Q. Okay. Now let's go back to 585. You've testified that for
  - 18 a long time you had a very close family relationship with 585, is
  - 19 that correct?
- 14:51:54 20 A. Yes.
  - 21 Q. But since the events we've been discussing early last year
  - 22 in February, you no longer have a good relationship with 585, do
  - 23 you?

  - 26 compound. She would greet me and I would greet her. If she has

- 1 A. Well, I believe so.
- 2 Q. You believe what?
- 3 A. I believe that she has isolated herself from me, and I have

- 14:52:57 5 Q. And isn't that because she's upset that someone as close to
  - 6 her as you were would put her in the horrible position of going
  - 7 to the Court and changing her testimony for money and that you
  - 8 offended her by saying that to her. Do you understand that?
  - 9 A. I don't understand that. She has isolated herself because
- 14:53:30 10 she knows that I am her uncle. What she has done to me is
  - 11 illegal. She's not supposed to do that to me, to report me of
  - 12 something that is not my deed. That is why she has isolated
  - herself from me. And I, too, upon instruction, when the Judge
  - 14 instructed me not to contact them. That is why I have not been
- 14:53:50 15 talking to any one of them. That is why I have isolated myself.
  - 16 Q. I understand that. Now when you and I met last year, did
  - 17 you tell me that you didn't have any reason to approach these
  - 18 witnesses on behalf of Prince Taylor about recanting their
  - 19 testimony? Did you tell me that?
- 14:54:22 20 A. Yes, I told you.
  - 21 Q. Okay. Let me suggest to you at least a possible motive -

  - 24 Prosecution witnesses who had testified at The Hague? Are you
- 14:57:32 25 aware that Prince Taylor did that? Did he tell you that?
  - 26 A. I've not heard you clearly. I want you to repeat it.
  - 27 Q. Are you aware that in December of 2010 Prince Taylor
  - 28 assisted the Charles Taylor Defence in filing a motion with the
  - 29 Court to bring back for more testimony four Prosecution witnesses

- 1 who had testified for the Prosecution in the Charles Taylor case
- 2 and had been relocated?
- 3 A. I don't know. I don't know anything about that. I was not
- 4 working with that man. I was not talking with him. I did not
- 14:58:27 5 even know him. I told you that day that I don't know him and I
  - 6 wanted to know him. I never knew him.
  - 7 Q. Let's talk about Aruna Gbonda. He's a really fine
  - 8 gentleman, isn't he? Wouldn't you say?
  - 9 A. Well, you've seen him. You say he is fine. I wouldn't
- 14:59:00 10 refute that.
  - 11 Q. Well, I also said that he was a gentleman. Would you agree
  - 12 with that?
  - 13 A. Well, for the respect of our party, and he's a key player,
  - 14 yeah, he's a gentleman.
- 14:59:26 15 Q. I believe you testified this morning on direct examination
  - 16 that Mr Gbonda told you that he was promised money and relocation
  - 17 but he didn't get enough money, that he complained about the
  - 18 Prosecution. Did you give that testimony this morning? Yes or
  - 19 no.
- 14:59:47 20 A. I said that. That's what they was grumbling about. That
  - 21 is what they was grumbling about what they met. I myself spoke
  - 22 with him when he game came from The Hague at the Court barri.
  - 23 That is when he grumbled about that. And I said wait, your time
  - 24 will come.
- 15:00:04 25 Q. So the answer is yes. The answer is yes.
  - 26 A. Yes.
  - 27 Q. And how many times did he complain to you about that?
  - 28 A. Well, I can say maybe twice.
  - 29 Q. Are you aware that around the time of this testimony he had

- 1 health problems and that he had three hernia operations and that
- the Court paid for one of those? Were you aware of that?
- 3 A. I don't know.
- 4 Q. You don't know about that?
- 15:00:47 5 A. I don't know about that.
  - 6 Q. Well, to borrow a phrase that's been used, I put it to you
  - 7 that he had no reason to complain to the Court and did not
  - 8 complain to the Court.
  - 9 Now -
- 15:01:06 10 A. He complained. Had he not complained, I wouldn't say so.
  - 11 I am an intelligent person. What he said I can remember. What
  - 12 he told me when he came from The Hague --
  - 13 Q. [Overlapping speakers] Answer the question. Wait for the
  - 14 next one. Wait for the next one.
- 15:01:23 15 A. Okay. I'm sorry.
  - 16 Q. It will come.
  - 17 A. Okay I'm sorry.
  - 18 Q. You say that he testified this morning Mr Gbonda came to

  - 21 A. Exactly.

- 3 Can you show P4 to the witness.
- 4 Q. Do you recognise that exhibit Mr Senessie?
- 15:04:04 5 A. Yes.
  - 6 Q. Okay.
  - 7 A. I have seen it. This is the manuscript that they read when
  - 8 TF1-585 said she recorded my voice.
  - 9 Q. Right. Now I'm going to direct your attention to the
- 15:04:24 10 paragraph where it starts:
  - "To the Charles Taylor Defence counsel ..."
  - Now, it is 585's testimony that you drafted this document,
  - 13 and it says:
  - 14 "I want to take this opportunity to call upon the defenders
- 15:04:46 15 of the above counsel that I am certainly ready to defend
  - 16 Charles Taylor in the Special Court in The Hague."
  - 17 Now, Mr Senessie, who drafted this that you read. Was that
  - 18 you or was that Prince Taylor?
  - 19 A. It was not me. I did not meet with Prince Taylor. What is
- 15:05:12 20 drafted here is not good English. It is below my level of
  - 21 education. I did not draft it. If I drafted it, it would not be
  - 22 like this. I do not know anything about this.
  - 23 Q. You understand that this statement, "that I am certainly
  - 24 ready to defend Charles Taylor in the Special Court ..., " what
- 15:05:46 25 that statement means that she is ready to go recant her
  - 26 testimony. Do you understand that?
  - 27 A. I understand it. That's what she wrote it on this paper.
  - 28 That's what she said, but I don't know anything about this. I
  - 29 don't know. I don't know it. Because if there was a duplicate

- 1 that had my signature, my original my autograph, maybe I will
- 2 remember that that's my signature. But this is just a draft.
- 3 Anybody can do this.
- 4 Q. Hold it, Mr Senessie. First of all, that's not a
- 15:06:28 5 statement. That is a transcript of the tape. It doesn't have a
  - 6 signature. The testimony is that she tape recorded your voice on
  - 7 that conversation. And then the investigator put her memory card
  - 8 in the computer and the two of them together prepared that
  - 9 transcript. That's the evidence against you, Mr Senessie. Do
- 15:06:55 10 you understand that?
  - 11 A. I understand. But there is nothing that can prove if this
  - 12 TF1-585 really wanted to prove this, which would have been backed
  - 13 by an affidavit. I think she should have signed this document
  - 14 and asked for a copy from me, which would have been a duplicate
- 15:07:18 15 of my holograph my handwriting, I mean. And should present
  - 16 that to the Court which would prove that, yes, this is Eric Koi
  - 17 Senessie's real handwriting. But she still has to prove that.
  - 18 My name is not there --
  - 19 Q. Hold on just a minute. Are you saying that this is, in
- 15:07:40 20 fact, your voice on the tape but that it's not official because
  - 21 she didn't sign it and come and show it to you. Is that what
  - 22 you're saying?
  - 23 A. I mean the document. This document before they read it.
  - 24 Before this person reads it, he may have drafted it first.
