- 09:02:57 10 Incidentally, Mr Herbst, I meant to pick up on one matter
 - 11 yesterday. In the course of your submissions and opening
 - 12 statement you referred to Brima. For purposes of clarity, I
 - 13 would prefer that you refer to Kamara by his surname. I say that
 - 14 because there is also a convicted person with the surname Brima
- 09:03:42 15 and it can be a little confusing.
 - MR HERBST: Your Honour, the surname being [Overlapping
 - 17 speakers].
 - 18 JUSTICE DOHERTY: The surname of Kamara is "Kamara", the
 - 19 family name. There is another co-convicted person whose surname
- 09:04:09 20 is Brima, and when you refer to "Brima", I automatically my
 - 21 brain tends to switch in to that co-accused, rather, but I am
 - 22 clear you are referring to Kamara. But for purposes of record,
 - it would be wiser to use "Kamara." Do you understand?
 - 24 MR HERBST: I do now, Your Honour. Let me clarify. When I
- 09:04:38 25 referred to Mr Brima, I was referring to the third convicted AFRC
 - 26 convict; in other words, there were the times when he, as well as
 - 27 the other two accused, were on the telephone. And so when I did
 - 28 refer to Mr Brima, I was referring to the third convict.
 - 29 Let me also report to the Court that there are times when

- 1 the video freezes so that we lose the video connection and the
- 2 last image that is transmitted is frozen on the screen. I don't
- 3 know whether that can be fixed, but it is a little disconcerting
- 4 for us here because we can hear what is transpiring, but we

 - 6 JUSTICE DOHERTY: The only way I can think of dealing with

 - 16 Mr Interpreter, can you repeat the last sentence? The line
 - is clearer now.
 - 18 THE INTERPRETER: The witness may have to repeat the last
 - 19 line.
- 09:16:05 20 JUSTICE DOHERTY: Mr Kargbo, we didn't hear what you said
 - 21 just now and I would like you to repeat it.
 - You said that you asked Kamara why, and then continue from
 - 23 there.
 - 24 THE WITNESS: He said when I asked him why, he said he
- 09:16:27 25 wanted me and others to help them --
 - 26 THE COURT OFFICER: Your Honour, may we ask Mr Herbst to
 - 27 intermittently turn off and on his mic. It seems his mic is
 - 28 permanently on.
 - 29 JUSTICE DOHERTY: Mr Herbst, could you turn off your

- 1 microphone? It seems it's interfering. Good.
- 2 Continue, Mr Kargbo.
- THE WITNESS: He said he would like me to talk to 334.
- 4 JUSTICE DOHERTY: Continue.
- 09:17:08 5 THE WITNESS: For him to recant his statement.
 - 6 JUSTICE DOHERTY: Yes.
 - 7 THE WITNESS: Then I asked him why.
 - 8 JUSTICE DOHERTY: Continue.
 - 9 THE WITNESS: Then he said because his lawyer in Ghana had
- 09:17:37 10 told him if they can talk to 334, for him to recant his
 - 11 statement, they will reduce their sentences or set them free.
 - 12 JUSTICE DOHERTY: Yes.
 - 13 MR HERBST: Your Honour --
 - 14 THE WITNESS: Then I asked him why he was saying that.

 - 22 Newton. Then I said, okay, let me go with you. On our way to
 - Newton I said, The message that I have for you is that Bazzy,
 - 24 Five Five, called me and told me that I should talk to you
- 09:22:26 25 because the promise that was made to you by the Special Court has
 - 26 not been fulfilled. So they want to raise funds for you so that
 - 27 you can recant your statement.
 - 28 Q. What did 334 say to you in reply?
 - 29 A. Then 334 said, if I know what I was saying. I said, I

- 1 don't know what I am saying. Then he said if I should recant my
- 2 statement, that would be a problem for me. It would be a
- 3 contempt of Court.
- 4 Q. What then did you do or say?
- 09:23:47 5 A. Then he said he said that would be a problem. Then I
 - 6 told him that those men are saying that we should help them.
 - 7 Then I said, even Papa wants to talk to you. Then he said, Okay,
 - 8 let me talk to him. Then he took the phone from me. Then he
 - 9 spoke to Papa. Then Papa said, Sam, that is what those men said.
- 09:24:34 10 Then 334 said, Okay, I've heard and I will think about it. Then
 - 11 334's countenance changed in the car. He changed his looks and
 - 12 he did not respond to me well any longer. Then he gave me the
 - 13 phone.
 - 14 MR HERBST: I'm sorry, Your Honour. I have to interrupt
- 09:25:08 15 and say that I am having great difficulty understanding because
 - 16 of the static, and I would ask --
 - 17 THE COURT OFFICER: [In Kigali] Your Honour.
 - 18 MR HERBST: -- the answer to be repeated.
 - 19 THE COURT OFFICER: [In Kigali] Your Honour, would it be

 - 21 MR HERBST: Thank you, Your Honour.
 - JUSTICE DOHERTY: I'm going to stop for a moment whilst
 - they try and sort this problem out because everyone is having
 - 24 difficulty hearing.

 - 26 MR METZGER: Slight point of correction. It may be because
 - 27 of the all the static, but I think that what the witness said
 - 28 Papa said was not "son" but "Sam."
 - 29 JUSTICE DOHERTY: Oh Sam, not "son." Thank you,

- 1 Mr Metzger, that's much more sensible.
- 2 Mr Herbst, did you hear that correction.
- 3 MR HERBST: I heard "Sam" as opposed to "son."
- 4 JUSTICE DOHERTY: Correct. I am going to pause now and see
- 09:28:41 5 if this noise can be eliminated.
 - 6 THE INTERPRETER: Your Honour, are you still getting that
 - 7 noi se?
 - 8 JUSTICE DOHERTY: Mr Interpreter, I'm not getting the noise
 - 9 now, and I'm going to ask if anyone else is getting it. There is
- 09:29:40 10 a bit of noise, and I believe I'm informed that the weather may
 - 11 not be helping this whole situation.
 - Mr Herbst, is your line any clearer? I notice you nodding
 - in agreement.
 - 14 MR HERBST: Yes, it is, Your Honours. Thank you.

 - 22 A. I met him at the Sarolla Hospital, and he told me he was

 - 26 Q. Before you got to P I'm sorry. Continue.
 - 27 A. When we got to PWD junction, then I brahim Bazzy Kamara
 - 28 called on the phone. When he called me I said, 334, these men
 - 29 have called me. Bazzy has called me. Then I picked up the call.

- 1 I and Bazzy Kamara were talking. Then he said, Sammy, have you
- 2 spoken to 334 for me? Then I said yes. Then I told 334 then I
- 3 told Bazzy that I was with 334 right now. Then he said, Let me
- 4 talk to him. Then 334 refused. He said he was not going to talk
- 09:35:20 5 to Bazzy. He didn't want to have contact with them.
 - Then I told Bazzy that that man said he was not going to
 - 7 talk to you. He doesn't want to have contact with you. Then he
 - 8 told me that he was going to drop his phone so that Five Five and
 - 9 Gullit, so that all of them can find a way to call him back to
- 09:35:51 10 talk to them so that he would put his phone on speaker so that
 - 11 all of them would hear what they would be discussing. Then I
 - 12 said, Okay, no problem.
 - 13 MR HERBST: Your Honour.

 - 12 Q. So am I correct to say all what the Court has done for you
 - is to provide an accommodation?
 - 14 A. The Court never gave me accommodation.
- 15:11:37 15 Q. Have you been provided any payment for transportation to
 - 16 come to Court and go back to your house or for food?
 - 17 A. From which area?
 - 18 Q. From WVS, have you received any payment?
 - 19 A. Yes.
- 15:11:59 20 Q. This is what I was trying to get you to answer since this
 - 21 morning. Are you in a position to tell the Court how much you
 - 22 have received in terms of transportation allowance or food
 - 23 allowance?
 - 24 JUSTICE DOHERTY: Two questions in one. Take them one at a

 - 26 MR NI COL-WI LSON:
 - 27 Q. Can you tell the Court how much you received in terms of
 - 28 transportation allowances?

- 4 MR HERBST: Sorry, Your Honour. I didn't hear that answer.
- 15:12:59 5 JUSTICE DOHERTY: When the Court started.
 - 6 MR NI COL-WI LSON:
 - 7 Q. And are you in a position to give an approximation in terms
 - 8 of how much you may have received?
 - 9 A. Maybe if you will give me time, but right now I can't give

 - 11 Q. And also you have received some payments for food
 - 12 allowance?
 - 13 A. No.
 - 14 Q. So you've not been given either food or money for food by

I was going to wait, Your Honour, to do 8 an application after the testimony of 334. But I will say since 9 334 is ill and cannot make himself available to the Trial Chamber at the moment, Mr Bangura should not continue to stay in custody 15:42:28 10 11 on the basis of having made a contact with 334. 12 Your Honour, I will continue to reemphasize the fact that 13 this contact has still not been proven to be correct.
