	27	This is the matter of the Independent Counsel v. Hassan.
	28	Papa Bangura for interim decision on an application for
	29	bail. Mr Nicol-Wilson has made a very impassioned plea on behalf

1 of the applicant accused Hassan Papa Bangura. He has stressed several times that the accused is no longer a flight risk. In 2 fact, he has said that he was never a flight risk; that he is in 3 4 steady business and family environment; that he has surrendered his passport; and that as the Prosecution case has now finished, 11:04:38 5 there is a change in circumstances. In earlier submissions he 6 7 also said that the witnesses have given evidence and that Hassan 8 Papa Bangura is no longer a threat to them. 9 Mr Nicol-Wilson also refers to the fact that the accused's passport has been surrendered and to his religious commitments. 11:05:10 10 11 The Prosecutor, in response, notes that there is no perceived 12 change in circumstances, other than his acknowledgment that the case for the Prosecutor has closed. 13 14 Interference with witnesses and the risk of flight are very onerous and heavy considerations for any Court in a case such as 11:05:35 15 this. I accept that Mr Nicol-Wilson, as an officer of the Court, 16 17 will not make a submission that is without foundation and has, as 18 the Prosecution said, spoken commendably on behalf of his client. 19 It is his power of persuasion that is here. After 20 considerable thought and weighing up the rights of both the 11:06:09 21 witnesses and the accused, I have given some considerable thought 22 to this situation and have decided that I will allow the accused 23 bail, pending the recommencement --24 Would the people in the public gallery stop clapping, 11:06:38 25 otherwise I might change my mind. We'll have proper decorum in this Court. 26 -- on the following conditions: (1), that the accused 27

enter a bail surety of 1.5 million leones forthwith; (2), that

each of three sureties put forward on behalf of Hassan Papa

- 1 Bangura by Mr Nicol-Wilson enter into a bond in the sum of 2.5
- 2 million leones. Each of the three securities is to come to this
- 3 Court to sign a bond and acknowledge that they will forfeit 2.5
- 4 million leones in the event of the accused not appearing; that

 - 6 persons designated by her on each Monday, Wednesday, Friday and
 - 7 Saturday; that he will not leave the country; that he will not
 - 8 approach any witness or any co-accused by any direct or indirect
