## Taylor's Lawyer rejects change of venue

Defence Lawyer, Karim Khan, representing the Special Court indicted war criminal, ex-president Charles Taylor, has engaged in what has been referred to as a legal battle with the Appeals Chamber of the court, by advancing a motion on behalf of his client, challenging efforts by the court to conduct the trial of Mr. Taylor in a third country.

The reason for his objection to the move is that his client, the former president of Liberia, Mr. Charles Taylor, is yet to state his position on the issue for which he is being detained by the court.

The president of the Appeals Chamber has since dismissed the motion.

# Appeal Court Judge Resigns

Justice Gelaga King of the Court of Appeal is reported to have tendered his letter of resignation last Monday to the Chief Justice Dr. Ade Renner Thomas.

According to reports, it is alleged that, there is a rift between Justice King and the Chief Justice. The reports further stated that Chief Justice requested Justice King to take over as Director of the Sierra Leone Law School, but refused on the grounds that Prof. Tuboku Metzger who is the Director of the school has not been retired from the office and that because of mounting pressure and the violatile situation existing in the office he decided to resign.

Prof. Metzger reports continued, is the first Director of the Sierra Leone law school from 1990 to date and is reported to have been doing remarkably well. Over two hundred men and women including thirty three Gambians have passed through that law

school under the leadership of Prof. Metzger who was the first Deen, Faculty of Law at Fourah Bay College, University of Sierra Leone.

The report also states that when the Chief Justice was confronted with a problem with Prof. Joko Smart at FBC years back, he resigned, and took up a teaching job.

"Justices Metzger and Gelaga King have done remarkably well for which they must be compensated with good works instead of frustrating them." A member in the bar said.

When contacted, the Master and Registra, Musu D. Kamara confirmed the resignation of Justice King.

"We were informed by the lordship Chief Justice Dr. Thomas that Justice Gelaga King has resigned during our management meeting on Monday chaired by the Lordship Chief Justice Dr. Ade Renner Thomas," Mrs. Kamara said. I cannot say any thing because I don't have any idea about that.

## Reuters Liberia expects an EU country would jail Taylor

Liberia expects a European country to offer to jail former President Charles Taylor if he is convicted of war crimes at the International Criminal Court, the country's new leader said on Wednesday.

"I am cautiously optimistic," Liberia's President Ellen Johnson-Sirleaf told reporters during a visit to London. "I think a (EU) country will rise to the challenge."

Taylor is awaiting trial in the West African country of Sierra Leone on 11 counts of war crimes and crimes against humanity for backing rebels during Sierra Leone's 1991-2001 civil war.

The United Nations is seeking to move the trial to the ICC in The Hague amid security fears but the process has been stalled as no third country has yet volunteered to act as Taylor's jailer if he is convicted.

Denmark, Sweden and Austria have all refused. British Prime Minister Tony Blair said last week that Britain was willing to help resolve the impasse.

"We understand that is a major question ... if there is a way we can help in that, we will," he told a news conference.

Liberia is also keen to see Taylor moved from its neighbor Sierra Leone and fears a prolonged trial there could increase risks of instability in the region.

## Judge declines Taylor's bid for new venue

Freetown - The Special Court for Sierra Leone has dismissed an application by former Liberian president Charles Taylor challenging a bid to change his trial venue, a court official said on Wednesday.

Taylor's lawyer Karim Khan filed a motion in April asking that the court's president either withdraw his request to transfer the trial to The Hague or that the defence be allowed to comment on the issue before a decision is reached.

The appeals chamber of the United Nations-backed court dismissed the motion on Monday on grounds that it sought to interject the trial and appeals courts into the "administrative and diplomatic functions of the president (of the court)".

The ruling handed down on Monday said the procedure for change of venue is a matter spelt out in an agreement between the United Nations and the Sierra Leone government.

"Neither the statute nor the rules authorise a chamber to intervene in the administrative and diplomatic functions entrusted to the president."

"At this stage of the proceedings, matters relating to the venue of the Taylor trial are exclusively within the administrative and diplomatic mandate of the president," said the ruling, a copy of which was obtained by AFP on Wednesday.

The judge of the appeals court who handed down the ruling, Justice George Gelaga King, is now the president of the Special Court effective last week.

The Special Court for Sierra Leone, established in 2002, has requested that Taylor's trial be moved to the International Criminal Court (ICC) in The Hague on security grounds.

A much-awaited green light from the UN Security Council on the shifting of the trial has been stalled by lack of takers to jail Taylor if he is convicted of war crimes and crimes against humanity.

Austria, Denmark and Sweden have turned down requests to imprison Taylor, who has pleaded innocent.

A court source told AFP that King will decide in the next few days whether to follow through his predecessor's request that the trial be taken to The Hague or order that it be held in Freetown.

Once one of Africa's most feared warlords, Taylor is accused of inflicting some of the worst violence on civilians ever committed on the continent.

The 58-year-old former rebel chief is considered to be the single most powerful figure behind a series of civil wars in Liberia and neighbouring Sierra Leone between 1989 and 2003, which between them left around 400 000 people dead.

## Sierra Leone war crimes court rejects Taylor challenge to venue change

Justice George Gelaga King, newly-elected president of the Special Court for Sierra Leone (SCSL), has dismissed a defense challenge to a prosecutor's motion to move the trial of former Liberian president Charles Taylor from Freetown, South Africa to the International Criminal Court (ICC) at The Hague in the Netherlands. Taylor, who is being tried on 11 counts of war crimes and crimes against humanity under a revised amended indictment argued that the venue change would affect the availability of scheduled witnesses and insisted there was no evidence that a Freetown trial would be unfair. King dismissed the challenge because such motions for venue shift are part of the administrative functions of the president of the SCSL and are not matters for the appeals chamber of the court to resolve.

Authorities in the Netherlands have said they will grant the request to relocate the trial to the ICC, but only on the condition that another country accept custody of Taylor immediately after proceedings conclude on the presumption he is convicted. So far UN negotiators have been unsuccessful in finding a country willing to take custody of Taylor, with Denmark refusing to take custody of Taylor after the trial. Both Austria and Sweden have also rejected custody requests.

## 'Nigerian army ready to testify in Taylor's trial' - Chief of Staff

Newly appointed Chief of Defence Staff (CDS), General Martin-Luther Agwai, says the Nigerian Army will give evidence against former Liberian President, Charles Taylor if invited by the International War Crimes Tribunal.

Agwai spoke in Kaduna yesterday at the quarterly Chief of Army Staff (COAS) Conference. He stated that since the Nigerian Army participated in the peace-keeping operations in Liberia during the Liberian war, it would not shy away from giving evidence before the international court.

The Defence Chief told journalists after the two-day meeting that, "when the procedure comes and if there is need for humanity, and for putting the records right, I am sure the Nigerian Army, if called through the appropriate channels and if the country finds it necessary, the Nigeria Army will do so (give evidence)." He added:

"Unfortunately, I am not a lawyer, I don't know the procedure of the international court. I cannot predict now or say what procedure it is going to take and I cannot pre-empt it now."

Agwai explained that "peace-keeping is an area that Nigerian Army has a lot of experience," noting that since 1960, "we have participated in over 25 peace-keeping missions through the United Nations (UN), African Union (AU) and Economic Community of West African States (ECOWAS)." "We have a lot of experience, but peace-keeping itself has become more complex. There is more involvement by non-governmental organisations (NGO's), the international community and the world has become a global village," he said.

To strengthen the capacity of soldiers in such endeavours, Agwai hinted that the Nigerian Army would set up a peace-keeping wing at the Infantry Centre and School at Jaji. "The unit," he said, "would train soldiers going on peace-keeping and also enlighten them so that they know each other before they move to the mission area.

"Remember also that the soldiers' first point of duty is, shoot to kill but, while you go for peace-keeping, even when people shoot at you, you are encouraged not to shoot. We have achieved well in the area of peace-keeping operations."

On the problems faced by soldiers in the country, Agwai listed them as accommodation in the barracks, facilities like water, equipment, refurbishment and re-kitting of soldiers".
