Five teams of three students have been pre-selected based on their knowledge of IHL to participate at this competition. Whilst the legal case they will work on is purely fictional, they will face

a panel of experts in a real court setting in the Special Court for Sierra Leone.

The Head of the ICRC Delegation in Freetown, the legal adviser of the Sierra Leone Red Cross, a Sierra Leonean Judge from the Special Court for Sierra Leone, representatives of the two

concerned universities and the Deputy Secretary at the Ministry of Foreign Affairs and International Cooperation will judge the students on their knowledge of IHL and public international law, their capacity to use the instruments of law

Sierra Leonean experts in IHL will coach and train the three students of the winning team, whom ICRC will sponsor to represent Sierra Leone and their university in the international stage of the competition in Arusha (Tanzania) from the 12<sup>m</sup> – 20<sup>th</sup> November 2005.

The ICRC is organizing this event within the framework of its mandate to support the efforts of States in disseminating International Humanitarian Law.

# US\$10 million pledged for Special Court

The United Nations is determined that the Special Court For Sierra Leone must not now fail due to lack of resources, UN Deputy Secretary -General Louise Frechette said this week at the end of a Pledging Conference where US\$10million was raised for the court.

The Special pledging ceremony was attended by the Chief Prosecutor, Mr. Desmond De Silva and the Registrar, Mr Robin Vicent. The court is trying to get U.S \$26 million to fund the court's operations next year. The 10 million collars came from pledges from the U.S, Britain, Canada, the Netherlands, Denmark, Australia, Belgium, Norway, Ireland, Turkey, Finland, Germany, Italy, Austria, Greece, Sweden and the European Union.

# Women seek power as Liberia prepares to vote

MONROVIA, 8 Oct (Reuters) - From girls in high heels brandishing Kalashnikovs to a grandmother who wants to be Africa's first female president, women in Liberia have always been a potent force.

But as the nation prepares to vote in its first elections since one of Africa's most brutal wars, women are taking over the political scene like never before.

More than half of the 1.3 million people registered to vote in Tuesday's polls are female, a statistic none of the 22 presidential candidates can afford to ignore. Two of the candidates are women.

One of the frontrunners in the presidential race is Ellen Johnson-Sirleaf, a 66-year old former World Bank economist who lists being the granddaughter of a market woman as one of her top credentials.

# Sketches of Liberia's contenders ahead of October 11 presidential vote

MONROVIA, 8 Oct (AFP) - Of the 22 presidential contenders for Liberia's elections October 11, only five are considered strong candidates to succeed the two-year transitional administration led by Gyude Bryant.

No candidate holds a winning majority and it appears likely that a run-off set for November 8, two weeks after results are officially certified, will take place.

Leading the pack are football great George Weah and political veteran Ellen Johnson Sirleaf, both of whom could make history if elected to lead Africa's oldest independent republic and steer the war-ravaged west African country away from its legacy of conflict and corruption.



# **UN ACTIVITIES**

The Deputy Special Representative of the Secretary-General (DSRSG) in UNAMSIL, who is also UNDP Resident Representative to Sierra Leone, Victor Da Silva Angelo Tuesday visited Pujehun District, in the south, where nine chiefdoms out 12 had been hit by flood in May this year leading to 5,000 people homeless. The DSRSG disclosed that he was in the district to know the problems of the people and see how the UN could strengthen partnership to solve those problems, and to complement the efforts of other UN agencies.

The Deputy SRSG also disclosed that the UNDP was sponsoring a youth project for 15,000 youths nationwide to help develop their skills and create job opportunities for them, since the issue of youths was critical to the sustainability and consolidation of peace in Sierra Leone.

Meanwhile the WHO Representative to Sierra Leone, Dr. Joachim Saweka has urged traditional leaders and local councilors to cooperate with the Ministry Health and Sanitation to eradicate poliomyelitis disease in the country. He said the campaign was urgent in raising awareness to ensure that every child was immunized.

## **ECONOMY**

The Chairman of the Board of Directors of the National Insurance Company (NIC), Peter Kuyembeh yesterday disclosed that the company has paid Le200 million to government as dividend for the year 2004. He described 2004, "as most encouraging."

# **HUMAN RIGHTS**

Workers of the Kenema Town Council in the east, have resorted to an industrial action by setting fire to several office equipment because of non payment of their salaries for four months, and the sacking of 52 of their colleagues.

The Committee for the Protection of Journalists (CPJ), a US-based organization, has expressed concern at the continuous incarceration of the Editor and Proprietor of the *For Di People* newspaper, Paul Kamara, who was jailed by a Freetown Court for seditious libel against the President Alhaji Ahmad Tejan Kabbah on 5 October last year to serve a two-year sentence. The Executive Director of CPJ, Ann Cooper said the continuous detention of the editor was in contravention of democratic principles.

## **POLITICS**

Lawyer Charles Margai, one of the defeated Presidential candidate for the ruling Sierra Leone Peoples' Party (SLPP) for the 2007 Presidential and Parliamentary elections at the Makeni Convention last month, has resigned from the party. In a letter to the Chairman of the party yesterday, Mr. Charles Margai wrote, "following events preceding and leading up to the SLPP convention held in Makeni on Saturday 4 September, 2005 and its aftermath, I embarked on a nationwide tour of the country to consult with the electorate on the way forward. At the conclusion of the tour, I was left in no doubt that the people's mandate was unequivocally in favour of the formation of a Third Political Force."

"The reasons advanced were that the SLPP and the All People Congress (APC) have both failed to address their concerns namely; solving the perennial countrywide blackout, proving pipe borne water, providing and maintaining good roads, solving the acute unemployment, providing food security at affordable costs, inability to tackle growing poverty in the country. The list is endless."

"On careful reflection on the above, I have come to the irresistible conclusion that the concerns expressed by the people are legitimate and have therefore decided to be part of the driving force in the discharge of that mandate with a view to rekindling the hopes and aspirations of our suffering people, if only to stabilize this nation.

By reason of the premise, I hereby tender my resignation as a member of the SLPP."

The former Minister of Local Government and Community Development, and Internal Affairs in the President Alhaji Ahmad Tejan Kabbah-led government, has already formed his own party, the Peoples' Movement for Democratic Change (PMDC).

# Nigerian president arrives in Liberia for pre-election talks with candidates, officials

MONROVIA, Liberia (AP) \_ Nigeria's president arrived in Liberia on Friday for a day of talks with the country's interim leader and candidates running in the country's first postwar elections next week.

Nigerian President Olusegun Obasanjo played a key role in brokering a 2003 peace deal that ended a rebel assault on Monrovia and paved the way for then-President Charles Taylor to resign and go into exile in Nigeria.

Liberian state radio said Obasanjo would meet with some of the 22 candidates running in the Oct. 11 poll.

In Nigeria, Obasanjo spokeswoman Remi Oyo said ``the essence of the visit is to show the solidarity of the president," who is also chairman of the continentwide African Union. Liberians are supposed to vote for a new president and legislature to replace the interim government that came to power after former warlord-turned-president Charles Taylor stepped down two years ago.

Among those running for president are African soccer legend George Weah and former rebel leader Sekou Conneh and Ellen Johnson-Sirleaf, a Harvard-educated politician who lost to Taylor in a 1997 vote.

Liberia's civil war began in 1989 and left up to 200,000 people dead in this West African country of 3 million.

Nigeria sent troops to Liberia as part of a peacekeeping force, both in the early 1990s and again in 2003. About 15,000 U.N. peacekeepers are still deployed in the country.

"For the Nigerian government, a peaceful, fair and free election and a return to democracy in Liberia will be a crowning glory to the men and women that we have lost, to the materials and money that we have put into keeping peace in Liberia," Oyo said.



# Obasanjo in Liberian poll talks

Nigeria's President Olusegun Obasanjo has arrived in Liberia to meet the 22 presidential candidates taking part in next week's first post-war election.

He played a key role in brokering a 2003 peace deal and granted asylum to Liberia's ex-President Charles Taylor.

He also ensured the polls take place on time when he persuaded two politicians' who had belatedly been allowed to join the presidential race, to withdraw.

Some 15,000 UN soldiers are in Liberia to ensure peace after 14 years of war.

Ex-footballer George Weah and economist Ellen Johnson-Sirleaf are among the favourites to be the next president.

Mr Taylor's National Patriotic Party is also fielding a candidate, Roland Massaquoi.

A vice-president and members of parliament will also be selected at the polls next Tuesday.

### **Chaos threat**

The BBC's Mark Doyle in the capital, Monrovia, says Nigeria is regarded as Liberia's big brother.	

Nigeria sent troops to Liberia as part of a peacekeeping force, both in the early 1990s and again in 2003.

Interim leader Gyude Bryant thanked Nigeria for its role in Liberia's peace process.

"In our recent history, Nigeria has done more for Liberia than any single member state of this global world," Mr Bryant said.

Recently Mr Obasanjo stepped in when a legal hitch threatened the postponement of the elections, our correspondent says.

A Liberian court ruled at the last minute that two presidential candidates who had been barred from standing could in fact stand.

But ballot papers without the two names had already been printed and the court ruling risked throwing the whole election process into chaos.

President Obasanjo summoned the two politicians to Nigeria and somehow persuaded them to withdraw their candidacies.

Since granting Mr Taylor asylum two years ago, Nigeria has come under pressure to hand him over to the UN Court in Sierra Leone where he is wanted on war crimes charges.

Mr Obasanjo has said he will consider an extradition request if asked by Liberia's incoming president.
