Indict Gibril Wassaquoi Now!

THE PEOPLE of Kambia were rudely shocked and offended by some recent intellectual dishonesty being circulated in some sections of the local press, attempting to exonerate a high-profiled war criminal (par excellence) like Gibril Massaquoi, over the horrendous atrocities he committed against the peace-loving people of Kambia, on Wednesday, January 25, 1995.

A so-called Moses Kanneh claiming to defending Massaquoi, who called himself captain

> Gibo when he led the first ever invasion of his Ruf murderers, rapists and arsonists in Kambia, disrupting the peaceful coexistence of a harmless people.

It was a chilty Wednesday morning. Office workers and school children were preparing for the day's routine when disaster struck by 8 am.

I was leaving in the part of the town called Thayiray which hosts majority of the town's schools including Kolenten Secondary School and from where the bulk of the rebels entered that morning, although, other pockets of them entered through town virtually laying it under siege.

Nobody at the time knew what was exactly happening or who these "strangers," we saw trooping down town in droves where from that early morning. They didn't fire a single shot at first. They all had traveling bags on their breks and tooked not and rig-tagged, with a first, and nothing fa-

Everybody started questing who these strange creatures were, and what was their purpose of coming to Kambia. They said nothing to nobody. Soon, we saw another band of them, among them the seven catholic nuns who were staying at the Polio Children's home, near Kolenten School.

By the turn of events, it was apparent the nuns were under hostage and were being paraded. They started telling residents to go in doors and lock.

By 8:30 am, there was the first shot from downtown and other shots around us.

Soon, there were gunshots all over the place, explaining the meaning of all the strange movements.

At this time the rebels started breaking doors and forcing residents out on the street.

Hundreds were held hostage including schoolchildren in uniform that were captured on their way to school that morning.

From my hiding place, I saw one of the nuns, Sister Andrena giving first aid to a Kolenten pupil in uniform who was shot in the arm by the rebels.

The killings, burning, teoting and abductions suggest. Gibril Massaquoi who had commandeered a trade cost X-L Honda was

seen parading the length and breath of the town with a white towel hung on his neck. The bike belonged to then Red Cross field-officer, Mr Adikali Edison Kamara, (now deceased).

It was an unpardonable lie by this Massaquoi cohort, Moses Kanneh, insuniating that there was an exchange of fire between Massaquoi's rebels and the RSLAF deployed there at the time under the command of one Major Tamba Abu. Not at all. The rebels pillaged the virtually town unchallenged by no force whatsoever. Not even by the then SSD commander of the district, the dreaded OC Scorpion.

As Gibril Massaquo bimself bluffed at the height of the siege;"we are effectively in charge of Kambia, and the people of Kambia are presently

at our mercy." The atrocities committed by Gibril Massaquoi on the defenseless people of Kambiathat day are beyond imagination.

Apart from the fact that he physically abducted the seven nuns and more then 100 school children in uniform, scores of civilians were also murdered in cold-blood under Massaquoi's command.

I saw 18 year-old Isatu Bangura shot on her private part, leaving behind her then two weeks old baby boy.

Sembu, a veteran footballer and one of the town's best shoe makers was battered to death with sticks while his old father later died from gun-

shot wound on his thigh. Manso, popularly known as "Actor" and one of Kambia's finest tailors was shot dead in cold-blood at his electricity road residence, a few metres from Sembu's.

Pa Sidikie, a veteran chiefdom police was shot because they found his picture inside his parlour and was told to produce a pistol which he didn't possess in the first

How about 80 year-old Pa Alhaji Conteh of Yomrayah street. He was stabbed multiple times to death when he could not produce US dollars the rebels claimed were sent by the old man's numerous children abroad.

What about Yousif Zeghir, Dauda Kamara and Baby Amie Turay who were butchered by Massaquoi after they attempted to escape. Baby Amie died later at the Kambia Hospital after being stabbed an incredible 33

times! If all these do not amount to war crimes or crimes against humanity which crimes did Massaquoi commit. then?

Infact, what Massaquoi did to the nuns is a different matter. But for the school children he abducted that fateful morning, more than half never returned. Man-- Dangura, a roim it pupil

he abducted at the time and turned his concubine. When Massaquoi emerged from the jungle after overthrowing the democratically elected government in 1997, he informed the girl's parents that she had died in the jungle. Under what circumstances still remain a mystery as the poor parents continue to mourn in silence till this day.

If the Special Court is here to try those with the greatest responsibility of the decade old brutal war, Gibril Massaquoi should be prime suspect of course.

It is a pathological lie that the late Komba Gbundamaled the 1995 invasion of Kambia. Komba was just a troublesome physically handicapped sergeant at the time and Massaquoi a captain and the "Commando Gibo!"

So Moses Kanneh or whosoever you are, the people of Kambia are not morons at all, and will sit by and allow you to make a no-case submission for Massaquoi by grossly distorting the facts at their detriment. Facts are abound for David Crane to rope Massaquoi as a war criminal. Any attempts to pamper him will surely undermine the objectivity of the Special Court, and erode its intent and purpose.

Kambia will be there to nail this war criminal!

"This is the day I've been waiting for, the day when someone would be made to answer for what the rebels did to me, "said 20-year-old Jabati Mambu, a student whose right arm was amputated by Sierra Leonean rebels during their invasion of the capital, Freetown, in January 1999.

"I am now handicapped and have lost the better part of my youth-hood," Mambu added, as the trial of three top officials of the Revolutionary United Front (RUF) got underway earlier this week.

"The rebels attacked our house in the East of Freetown and abducted my two sisters after raping them. They then slashed off my arm with a blunt machete. I will never forgive those monsters and would only be satisfied if the court punished their leaders."

The RUF, formerly a rebel movement, terrorized parts of Sierra Leone during a civil war that raged for much of the 1990s, fuelled and funded by diamonds illegally sold on world markets.

The group's tendency to amputate limbs, notably those of civilians, became its trademark - and is one of the reasons why three RUF officials made their first appearance Monday, July 5, before a war crimes tribunal set up in Freetown (the "Special Court for Sierra Leone").

"These three war crimes indictees are dogs of war and hounds from hell. Their motive for fighting was less political and much more criminal," said David Crane, chief Prosecutor of the court, Monday.

"It is a chilling tale of horror, a joint criminal enterprise that scread beyond Sierra Leone and involved external prayers like are round; programme and involved external

The accused include Issa Sesay, who took over as leader of the RUF when its previous head - Foday Sankoh - was arrested in 2000. The group's chief of security, Augustine Gbao, and Morris Kallon - also known as Bilai Kareem - are the other officials to go on trial this week.

They are facing an 18-count indictment for war crimes such as unlawful killings, terrorising the civilian population, sexual violence and abductions - and the use of child soldiers.

While all three have asserted their innocence, they have also challenged the authority of the court to try them - and indicated that they will take the matter up with Sierra Leone's Supreme Court.

The war crimes tribunal, which has the backing of the United Nations, is funded by Britain and the United States. It was established in 2000, and observes local and international laws. It is also staffed by legal minds from both Sierra Leone and other UN states.

"This is a constitutional matter. I don't see how this court can be over and above even the Supreme Court of the country," a defence counsel for one of the accused told IPS Tuesday.

But, Sieh Mansaray - like Mambu - welcomes the trial. He had gone to search for food in the eastern diamond-rich city of Kono when he encountered the RUF, in 1998.

"They lined us up, 24 in number. Twelve of us were amputated and the rest shot dead. The rebels then told us to go to President Kabbah to fix our limbs because we voted for him," he told IPS.

Ahmad Tejan Kabba was elected president of Sierra Leone in 1996, but was deposed the following year by a group of army officers and RUF members. The intervention of regional troops enabled his return to power a year later - but in January, 1999, the RUF managed to re-occupy sections of Freetown.

erra Leone's civil war was only declared over in January 2002

The tribunal is the only war crimes court to be operating in the country where the abuses in question occurred. Its mandate is to try individuals who allegedly bear the greatest responsibility for atrocities perpetrated in Sierra Leone since November 1996, when Kabbah signed his first peace deal with the RUF.

To date, the court has indicted 13 people, including Charles Taylor who is currently exiled in Nigeria. Taylor is accused of being principally responsible for war crimes in Sierra Leone, for his role in arming the rebels in return for "conflict diamonds."

The other accused are drawn from a militia known as the "Kamajors", which backed the government during the war, and the Armed Forces Revolutionary Council: the junta that overthrew Kabbah in 1997. Former council leader Johnny Paul Koroma is also on the run from the count.

The deaths of RUF founder Sankoh and his notorious field commander, Sam "Mosquito" Bockarie, last year have left some feeling that court proceedings are irrelevant. The men were considered two of the main architects of the destruction in Sierra Leone.

Sankoh's health declined after his arrest on war crimes charges, and he died of natural causes. Bockarie was killed while fighting in Liberia's civil war.

Adds James Conteh, a cab driver in Freetown, "If they can't rope in Taylor - and locate and arrest Johnny Koroma - what then is the use of the court?"

Court spokeswoman Alison Cooper told IPS Tuesday that every effort is being made to bring Taylor to justice. However, the tribunal can only appeal to Nigeria to hand Taylor over - not compel it to do so.

To date, Abuja has not indicated any willingness in this

Based on this report, New Vision dispatched a reporter to the area over the weekend only for him to collaborate the report.

Our source further claim that these security operatives take foodstuff from poor farmers who go to sell their wares in what they refer to as 'specimen'

One of the checkpoints renowned for extortion of money and foodstuff is the Jendema checkpoint at the Mano River Bridge where security personnel collect fish, gari, palm oil, and other vegetables. Even travellers carrying official Government documents and identity cards were not spared in this joint 'taxation' to the extent of creating unprecedented awe in the minds of detraumatised business people and travellers in Sierra Leone.

Speaking to a senior police officer (name withheld), our reporter quoted him as saying, "my friend, we and our families have to live". It could be recalled that following persistent report of extortion by the joint security personnel, the Commissioner of Police, Southern Region paid an on-the-spot visit to the Mano River Bridge and according to reports monitored, his investigation into the alleged extortion had some officer neited with some minor disciplinary action taken against them.

But it appears some officers were still not commensurately punished as the practice continues unabated.

A further visit was reportedly made by the Sierra Leone Ambassador in Liberia, Mr. Patrick Foyah, warning them to be vigilant in the discharge of the security duties, but no sooner had he left for Monrovia than they recommenced their good old dirty tricks, the report added.

What is creating concern to the community people was that the extortion proclivities of the security operatives is on a daily basis, extortion proclivities to leave their border posts as a field day for

smugglers of various goods including arms and adminimized putting the security of the country at risk.
