Prosecutor Welcomes Start Date in Taylor Trial, Promises Access for Sierra Leoneans

The trial of former Liberian President Charles Taylor is slated to begin this spring, as ordered by a Judge of the United Nations-backed Special Court for Sierra Leone. The case against Mr. Taylor, who is accused of committing war crimes and crimes against humanity during the civil war in Sierra Leone from 1996 through 2002, will begin on June 4.

At the Taylor Status Conference held on January 26 at the trial venue in The Hague, it was announced that the date for commencement of trial had been changed from the original date of April 2 at the request of the Taylor Defence to provide additional time for its preparations.

Justice Teresa Doherty, who presided at the Status Conference, made rulings on several other matters, including the setting of the date for the filing of pre-trial briefs. Taylor has pleaded innocent to charges of war crimes and crimes against humanity linked to the killing, mutilation, and sexual violence involving thousands of victims, as well as the recruitment and use of child soldiers.

Responding to reporters questions after the hearing concerning the nature of the Prosecution case, Stephen Rapp, The Prosecutor, said, The indictment alleged acts that included the most horrendous things humans can do to one another.

Whereas the other trials of the Special Court for Sierra Leone are being conducted in that nation capital, Freetown, the Taylor case will unfold at the facilities of the International Criminal Court in The Hague. The Prosecutor noted that the decision to move the trial was a result of negotiations aimed to keep the peace in Sierra Leone and the region as a whole. The decision was supported by the United Nations and the key governments in the region, including Liberian President Ellen Johnson-Sirleaf.

Mr. Rapp emphasised that while the trial has been moved due to regional security concerns, it is the Special Court for Sierra Leone, and only the Special Court, that is conducting this trial. I want to emphasise from the outset that this trial will be conducted first and foremost in the name of, and on behalf of, the people of Sierra Leone. Regarding concerns that the distance between The Hague and the Sierra Leonean capital would prevent the people of the country from witnessing justice being done, The Prosecutor spoke about the extensive Outreach programme of the Court.Last year, 780 meetings were held in every region of the country to inform the public of the Court work, Mr. Rapp commented. ╜Every effort is being and will be made to ensure that Sierra Leoneans have transparent access to this trial.

Between Chief Norman and PMDC

About two weeks ago, supporters of the Peoples Movement for Democratic Change (PMDC) circulated a press release purportedly signed by Chief Norman and eight other detainees at the Special Court in which they pledged their loyalty and support for the SLPP party.

That press release, a copy of which was obtained by the New Vision, was actually signed on the eleventh day of January 2007, some days before the departure of the former Kamajor Kin pin and RUF strong man to Senegal for medical treatment.

Upon obtaining a copy, the New Vision investigated the veracity or otherwise of the statement by speaking directly with Chief Norman in his hotel room in Dakar.

In that interview, Mr. Norman denied knowledge of the press statement and even vowed to make a formal rebuttal once he was through with his medications, a development which the New Vision reported.

Then a week later the PMDC organ 'Positive Change' came out with the same press release claiming that Norman and all indictees at the Special Court had actually declared their intentions to join the PMDC and not the SLPP.

It is the inalienable rights of people to join any political party of their choice. A right that the New Vision will not question nor undermine.

We are aware of the fact that Chief Norman had on many occasions before actually dissociated himself from any other political organisation other than the SLPP.

We also know that late last year he spoke via mobile phone to a group of ex-fighters in the Southern Provincial town of Bo and pleaded with them not to switch allegiance to any other party but the SLPP.

What is baffling us is the seeming double standards at play in the whole scenario.

As a matter of fact the New Vision reckons that the signature of particularly Chief Norman as it appeared on that statement, even if it was forged, was done so cleverly and to clear all doubts, we took the initiative to speak to him over telephone.

The only signature that we questioned was that of Musa Allieu Kodowei, as an illiterate, we were told usually signs with his thumb prints. But in the statement Kodowei signed at least like a semi literate, which a family member claimed was forged. That particular signature to us discredited the whole statement.

Furthermore, we are inclined to think that Chief Norman, being what he is, may never have signed that document only to disclaim it afterwards.

With his current predicament, he has nothing to lose by simply making a political choice.

However, for the PMDC to actually publish the story in its own mouth piece; gives some legitimacy to the document.

Before we pass judgment on the matter, we will only hope and pray for the safe return of Mr. Norman whose response will once and for all complete a notable political drama to a close.

During the normal routine beat of this reporter, he discovered that the strike action has rendered the smooth running of the court session ineffective, with no court sittings in the entire High and Appeals Courts. The same thing was prevalent at the magistrate courts.

According to reports, there are close to two hundred cases scheduled for hearing yesterday. But owing to the absence of legal personnel to represent their clients no sittings were commenced

Following a brief chat with some police prosecutors and court registrars, this reporter learned that the strike action is purely for solicitors. They disclosed that the effect of the strike action on the running of the courts is that large number of cases will not be heard.

A court registrar (name withheld) further explained that the courts are in their normal sittings. As a result all police prosecuted matters are still ongoing.

Outside the vicinity of the court building, majority of the people were not happy with the strike nation. In fact, they maintained that they merely wasted their precious time to come to court and only to be informed about another adjourned date.

The strike action itself was based on certain amendments relating to Section 24 of the Legal Practitioners Act 2000 which the Attorney General and Minister of Justice, Mr. Fred Carew has sought an amendment without prior notice to the Sierra Leone Bar Association.

Taylor's trial set for June 4

The lead prosecutor for the UN-backed Special Court on Tuesday said the trial of former President Charles Taylor would commence on June 4.

Mr. Taylor has been indicted for war crimes and crimes against humanity.

Chief Prosecutor Stephen Rapp said the trial represents the vindication of the principle that no person, no matter what their position, is above the law.

He also said the court has raised half the money needed this year for Taylor's trial.

According to the Chief Prosecutor, the court needed thirty-three million United States dollars for 2007.

Chief Prosecutor Rapp was appointed to the post last December.

To ensure transparency, the BBC World Service Trust will send two Liberian and two Sierra Leonean journalists to The Hague.

The journalists would be there for the duration of the trial so that they can report back to their home countries on the proceedings.

UNMIL Outlines Indian Police Women Responsibility

The Commissioner of the United Nation Mission In Liberia (UNMIL) Police CVPOL Mohammed Alhassan has outlined the responsibilities of the Indian Police Women Operations in their peacekeeping role in Liberian. Speaking at a Press conference at the UNMIL Headquarters yesterday in Monrovia, the Police Commissioner said the newly form Indian Police Women will join the task force patrol team of CVPOL and Liberia National Police (LNP) to patrol the city of Monrovia and its environs throughout the week.

Commissioner Alhassan said out of the 152 Indian Female Police there will be an anti robbery back up patrol team to help facilitate protection of residents.

He said there will also be a back up patrol team and a stand by group to tackle the problem of violence at any time.

Mr. Mohammed Alhassan said the essence of the Indian Female Police is to encourage Liberian Women to join the Liberia National Police (LNP) Force, noting that whatever male do women are capable of doing the same in the country.

He said UNMIL was excited about the Indian Police Women because it has been their desire that about 25% of the UNMIL Police Unit could be females since it provides an easy means of communication during investigation base on cases like sexual abuse.

The Indian Police Women who arrived in Monrovia on Monday January 29, 2007 will start a state of preparation by setting up their various offices to enable them work effectively.

They'ill also setup their operational logistics before commencing work to enable them carry out their operations easily and, finally they will undergo an intensive training with the history of Liberia, AIDS and Sexual Violence which will also enable them to work without encountering difficulties.

The Commissioner said the Indian Female Police Unit (FPU) has undergo series of training which qualifies them to carry out their operation in any part of Liberia but they will base in Monrovia and carry out their operations in Monrovia.
