By Betty Milton rosecution witness TF2-080 has told the Special Court that he stabbed a man to get a Sub Machine Gun support weapon. Led in evidence by the Prosecutor the witness said he joined the group voluntarily "when I joined the group, at that time there was no commander so everything was done all by ourselves. I had only a knife at that time." The witness said. "I was at the checkpoint when I saw troops going for Jah Jah meaning looting at Moyamba. There were two boys who were in my same age group so I. decided to join the group for the mission. When we

went, the rebels first attacked us but we overpowered them. It was during the battle that one rebel was shot, and as he was fighting to survive I stabbed him and took his gun from him." The witness said he joined the group because some small boys that were part of the group constantly harassed them Taiama. The witness said these boys used to send them to do certain jobs for them forcefully like carrying loads and even to fetch food. He maintained that since they had no commander, whenever they had a battle with the rebels, they will loot the properties and houses of civilians, and if they find out that there were soldiers among, they were burnt. "When we were manning a checkpoint we used to search the bags of civilians, and we even detained and beat big men." He said the only group that had a name at that time

Erstwhile Prosecutor of the United Nations backed Special Court, David Crane has alleged that last October extied Liberian President, Charles Taylor wired \$160,000 to his supporters in Monrovia to spark riots that killed twelve and injured over 200 people.

"He is funding the campaigns of his supporters in Liberia ahead of elections this October, and has every intention to return to Liberia," Crane maintained in a release from the Special Court. He made the allegations at the Second

The Special Court is an independent tribunal established jointly by the United Nations and the Government of Sierra Leone.

It is mandated to bring to justice those who bear the street responsibility for atrocities committed in Siena Leone after 30 November 1996.

To date, the Prosecutor has indicated thirteen persons on various charges of war crimes, crimes against humanity, and other serious violations of international humanitarian law.

Two indictments were withdrawn following the deaths of the accused.

Nine indictees are currently in the custody of the court.

'Taylor Is Directly Working With Terrorists,' Says Crane

War Crimes Chief Prosecutor in Sierra Leone, David Crane has renewed his allegations against exiled former Liberian President and indictee of the court, Charles Taylor of working directly with terrorists.

In a press release issued over the weekend, Crane said, "It certainly appears that Taylor is meddling in the internal affairs of several West African states and is working directly with terrorists," Mr. Crane said.

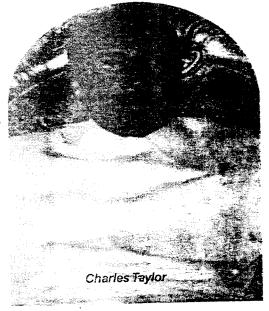
in a press statement over the weekend, Mr. Crane said that the government of Nigeria had warned Taylor on at least three occasions that he has violated the terms of his exile agreement.

"It is absolutely clear that from Nigeria, Charles Taylor holds a sword over the future of West Africa and Nigeria and the world owe him absolutely nothing," the release continued.

The release went on to accuse Taylor of fuelling riots in Monrovia last October that left twelve people dead and over two hundred injured.

"Just last week, through his spokesman, Taylor announced his intention to hold a press conference ahead of the Liberian elections due shortly in what the government of Nigeria said would be a violation of the terms of his exile," the release further stated.

Charles Taylor faces 17-count indictment for war

Why U.S. is After Charles Taylor - Aide

Fresh indications have emerged as to why the United States of America wants exiled former Liberian President, Mr. Charles Ghankay Taylor to face trial of war crimes in a UN special court in Sierra Leone.

US pressure to nail Taylor is not unconnected with the roles he played while in office as President of Liberia not to patronize US armament to prosecute the Liberian war which lasted for more than a decade, a close associate and aide of the former war lord has exclusively disclosed.

The associate who told THISDAY on the condition of anonymity, revealed that during the Liberian war the US government approached Taylor for sales of arms, but he turned down the request, adding that this singular action infuritated the US, hence they decided to lend support to Taylor's opponent.

According to the source, the current allegation by US that Taylor may be providing diamond which helps fund Al Qaeda operations, among other things could not be substantiated as it is like the case of giving a dog a bad name in order to hang it.

Again, THISDAY learnt that besides other facts, US is not happy with Taylor for his alleged continued interference in Liberia and other West African sub-region which may adversely affect US business interests in those countries.

The source further accused US of fuelling crises in the third world countries so that she could find market for her war equipment in order to continue to enrich her economy at the detriment of the developing countries.

It further reasoned that if US could stop funding crises in the world today, there would be peace in the globe, adding that because of her selfish business interest, she would not stop fuelling crises across the globe.

KAMAJORS WERE ORDERED TO BURN DOWN EVERY HOUSE OCCUPIED BY THE AFRC ... Witness testifies at CDF Trial

Monday June 6, 2005

Witness TF 2-078 has told the war crimes tribunal in Freetown that the Civil Defence Force were ordered to burn down every house occupied by members of the AFRC junta and to seize and use any property belonging the RUF rebels or the AFRC. From Freetown, Tamba Borbor reports:

Witness disclose plans for Operation Black December' at Special Court By Tamba Borbor from Freetown In the joint trial of the three CDF indictees- Sam Hinga Norman, Alie Kondowa and Moinina Fofana, witness TF2-079 has disclosed plans for Operation Black December'.

The witness said that the National Co-ordinator- Chief Sam Hinga Norman called them to a meeting where he informed them of the operation which he said was going to take place thus: all supply route to the RUF would be cut off; felling of trees on major roads and feeder roads- for which purpose they were given power saw to cut down the trees. Also, bridges were to be dismantled.

The witness went on, "the operation was to be carried out simultaneously as all RUF bases were to be attacked. Civilians and Police collaborators are to be treated as common enemies; all houses occupied by the AFRC were to be burnt and properties including vehicles belonging to the RUF or AFRC and collaborators should be owned and used by the Kamajors." The witness further disclosed that another meeting was also held at Walihun II where most members were present including the War Council authorities-Orenco, Nallo and himself.

At that meeting the witness said, Hinga Norman told them that gravel, which the AFRC Junta had dug, should be washed, sold and the proceeds be brought to him. The 43-year-old man who is also a member of the CDF told the Court that he first saw the second and third accused in November when he went to Base Zero at Talia to request for arms and ammunition as their supply had drastically reduced. "When we arrived, we went to the house where Hinga Norman was residing but we were told he had gone to Liberia. We were introduced to the Director of War- Moinina Fofana who received us with open arms after we had told him about our purpose.

The next morning, he took us to the house of the High Priest- Alie Kondowa. We stayed at Base Zero for three days during which Hinga Norman came and we handed over the Situation Report to him. He advised that some men return back with the arms in and ammunition that was given to us." He said that the lives of the civilians were also danger as anyone caught travelling between Tongo and the Kamajor base was killed. "A lad travelling from Tongo to Panguma on foot was caught and butchered by the Kamajors. Around the vicinity of Tongo, palm wine tappers were also killed by Kamajors," he narrated.

U.S. backs extradition of Liberia's ex-president / Official says the `time has come' for Taylor to leave Nigeria and stand trial for war crimes

CALABAR, NIGERIA - Nigeria is coming under increasing pressure to expel ousted Liberian President Charles Taylor so that he can face trial in a U.N.-backed war crimes tribunal, a move now supported by the United States.

Taylor vowed upon his departure to return to Liberia, but his spokesman, Vaani Paasawe, says a return to power is the last thing on Taylor's mind. Paasawe also said Taylor would break a long media blackout and hold a press conference Aug. 11.

According to Daily Observer, one of the FBI's most wanted persons, Mustafa Mohammed Fadhil is the link between former Liberian President Charles Taylor and the Al Qaida terrorist group.
